Need, Accountability, and Resource Availability in Third-Party Distribution Decisions

Abstract: We present a vignette study conducted with a quota sample of the German population ($n = 400$). Subjects had to redistribute a good between two hypothetical persons who contributed equally to the available amount but differed in quantity needed and the reason for their neediness. On a within-subjects level, we tested for the effects of need, accountability, and resource availability on their third-party distribution decisions. Between subjects, we further varied the kinds of needs: The persons either needed the good as a means to survive, to live a decent life, to participate in society, or to be autonomous. Despite equal productivity, the mean share allocated to the needier person was significantly higher than an equal share. However, this share turned out significantly smaller when the needier person was accountable for needing more than the other. Nonetheless, even if accountable, the needier person still got a share larger than their contribution would suggest. When there was a surplus of resources, the needier person got an even higher share than when resources were scarce.

1. Introduction

Recently, the eyes of the world have turned to Russia and Ukraine. And to the global oil and gas market. In the wake of the war, prices have surged, and joint European action has been proclaimed, with Commission President Ursula von der Leyen stating that “[w]e must become independent from Russian oil, coal and gas. We simply cannot rely on a supplier who explicitly threatens us. We need to act now to mitigate the impact of rising energy prices, diversify our gas supply for next winter and accelerate the clean energy transition” (European Commission 2022, par. 3). With or without secured supplies, the next winter is coming. And some people suddenly find themselves wondering: “What would I do if I couldn’t afford heating during winter?”

In the vignette study presented below, we look at two hypothetical persons, both short on money and in need of heating material. In this situation, they get the opportunity to chop their own firewood. Both manage to chop an equal amount of wood. Our subjects’ task, then, is to redistribute this wood among both persons in a way they deem to be most just. They can give each person exactly what they have chopped, resulting in an equal share. But: While both persons have chopped equally much, there are factors present that might lead subjects to distribute the wood unequally, nevertheless. For example, both persons can differ in their kinds of needs (i.e., they can need the firewood for different purposes), which may seem to be differently important: Should a person who needs the wood to survive get more than a person who needs the wood to make art in their studio? And if one person needs more than the other, should it make a difference whether or not this is due to self-inflicted health issues resulting from ignoring a doctor’s warning to stop smoking?

Hence, we investigate whether subjects’ ideas of justice, reflected in the hypothetical distribution decisions they made as impartial spectators, take into account factors like the kinds of needs or the accountability of a person, amongst others. In doing so, we contribute to the numerous empirical studies on laypeople’s distributive preferences that have been conducted in recent years (see, e.g., Bauer and Meyerhuber 2019, 2020 for perspectives on the interdependencies of such empirical endeavours and ethical theories). Those preferences have been shown to be pluralistic; besides equality and equity, *need* is regarded as an essential principle (see, e.g., Konow 2001, 2003, Weiß et al. 2017, also see Miller 2020) that is sometimes balanced against accountability (see, e.g., Konow 2001, Schwettmann 2009, Bauer et al. 2020).

We contribute to this literature by testing for the effects of need, accountability, and resource availability on third-party distribution decisions. Subjects distributed a good among two fictional individuals who contributed equally to the amount available but needed different quantities of the good. This was done with a quota sample of the German population, building upon prior work by Bauer et al. (2020).¹ Thus, as a follow-up study, large parts of our design are fairly close to the original work. Between subjects, we varied the kinds of experienced needs: The fictional persons either needed firewood to

survive, live a decent life, participate in society, or be autonomous. Within subjects, we further varied whether they had chopped more or fewer logs of wood than they needed themselves (a within-subjects variation already found in Bauer et al. 2020, albeit in a less systematic way) and whether or not one person was accountable for needing more wood than the other person (a variation that was originally done between subjects in Bauer et al. 2020). Subjects had to redistribute the firewood in 20 different cases. In the original study, the cases varied both the persons’ needs and productivity. We kept productivity equal and constant in order to alter the need as well as the resource availability in a more systematic manner.

Implementing the four different kinds of needs is a novel feature of our study. Also, compared to Bauer et al. (2020), we doubled both the sample size (from $n = 200$ to $n = 400$) as well as the number of distribution decisions each subject makes (from 10 to 20). Concurrently, we changed the parametrization of all cases instead of simply adopting some from Bauer et al. (2020). Our new parametrization is designed to systematically vary the *need share* of the first person (“Person A”) and introduces the two *supply scenarios* as a novelty compared to Bauer et al. (2020). With these changes, we hope to get more fine-tuned data on these factors.

There are no significant differences in distributive decision-making regarding the four types of needs (this might be because we have not made the four kinds of needs successfully salient). Despite this, we found that subjects distribute unequally favouring the needier person across all four treatments. The within-subjects analysis revealed that this is influenced both by accountability and resource availability. The mean allocated to the needier person is significantly lower when the person is accountable for their greater need. However, even when accountable, the needier person gets a share that still exceeds their initial contribution. In general, the needier person gets an even higher share when there is a surplus of resources than when resources are scarce. Hence, despite changes in the design of the follow-up study, key aspects of Bauer et al. 2020 were successfully replicated.

The remainder of this brief report is organized as follows: Section 2 very shortly introduces the study’s background. Section 3 then describes the study’s design. The results of our analysis are presented thereafter in Section 4. Finally, Section 5 concludes.

2. Background

When talking about need, we mean needs that are not purely instrumental but *fundamental*, *categorical*, or *basic* instead. Such needs are distinguished from mere wants, wishes, or desires and bear normative force. This might be the case, for example, when they are “necessary, indispensable, or inescapable, at least with respect to some important goals” (Brock and Miller 2019, par. 37).

Over time, the philosophical literature has proposed various lists of such needs, giving accounts of what specifically is deemed a need bearing normative force (e.g., Doyal and Gough 1991, Braybrooke 1987, Nussbaum 1990). Some oppose such lists, though. Hamilton (2003, p. 12), for example, states that “they are *meta*-political naturalisations

of historically contingent human needs and ends because they entrench a single moment in a dynamic process” and thus fail to grasp the true nature of needs. As an alternative to such lists, he proposes a categorization of needs using a triptych of classes, namely *vital needs*, *social needs*, and *agency needs*.

This, of course, is but the tip of the iceberg of the debate surrounding the concept of need. And there is little to no consensus as to the extent of needs (i.e., what does count as need and what does not) and the question of how to categorize or order them. Hence, we made a selection and chose four different kinds of needs that the literature often identifies as morally relevant: needs for mere survival, needs for a decent life, needs for social belonging, and needs for autonomy.² Survival needs might be the hottest candidate for consensus among need theorists. As far as we know, they all include such needs in their conceptions (to name but two examples, see Wiggins 1987 and Daniels 1985). Next, *decency* is often identified as important for needs. Prominently, Miller (2007, p. 3) argues that what he calls “basic needs” are “conditions for a decent human life in any society” (see also Miller 1999). Since humans “are social as well as biological creatures”, they “can be harmed by being denied the conditions of social existence” (Miller 2007, p. 3). Hence, we included needs for social belonging. Lastly, as Doyal and Gough (1984, 1991) point out, a person’s actions must not be imposed on them, they need autonomy (see also Hamilton 2003, Brock 2005, Siebel and Schramme 2020).

Obviously, there is a rich philosophical debate not only regarding (kinds of) needs in general but also regarding the concepts of decency and autonomy. This study, however, uses simplified interpretations of the four kinds of needs (see Section 3) to uphold an uncluttered design and not overwhelm subjects. Future studies should broaden the picture by taking into account different readings and aspects of those concepts. The same holds for the concept of responsibility or accountability.

When speaking of accountability, we have Konow’s principle of accountability in mind. This principle “calls for allocations to be in proportion to volitional contributions” (Konow 2001, p. 138) and demands that “individuals are only held accountable for factors they may reasonably control” (Konow 2001, p. 142). In the context of distributive justice, one might also think of *luck egalitarianism*, which argues that one being worse off than others can only be justified if they are accountable for being so. The effects of *brute luck* should therefore be compensated, while those resulting from *option luck* do not qualify for compensation.

While there is no empirical literature known to us that distinguishes between kinds of needs as we understand and categorize them, several studies are concerned with the interplay of need and accountability. A variety of studies found an influence of need moderated by accountability in different experimental settings and a wide variety of contexts (see Bauer et al. 2020 for an overview).

3. Study Design

We adopted a vignette from Bauer et al. (2020) that introduces two hypothetical persons, henceforth *Person A* and *Person B*. As both need firewood, the community they live in allows them to cut timber in the community forest. Subjects had the task to redistribute the total amount of wood chopped among the two in a way they deemed as just as possible (vignettes and instructions can be found in Appendix A). For the distribution tasks, subjects were given 20 different *cases* in which we presented Persons A and B as having different quantities of need. Their productivity was the same in all cases: Every time Persons A and B chopped an equal amount of 500 logs each. Thus the subjects had 1,000 logs in total to redistribute in every case.

The 20 cases were split into two *accountability frames* with 10 cases each. Bauer et al. 2020 have already shown that this manipulation works between subjects; we adopt it as a within-subject variation. In the *high accountability frame*, Person A has a metabolic disease since they smoked heavily even though their doctor advised them not to do so. Due to the disease, they need a warmer room and, therefore, more firewood than Person B. In the *low accountability frame*, Person A has a congenital metabolic disease, causing them to need a warmer room and, hence, more firewood.

Furthermore, both frames consisted of two *supply scenarios* with five cases each: In the *undersupply scenario*, Person A always chopped fewer logs of wood than they needed and it was impossible to fulfill both the needs of Person A and Person B given the total amount of logs chopped. In the *oversupply scenario*, on the other hand, Person A always chopped more logs of wood than they needed and the needs of Persons A and B could easily be fulfilled with the total amount of logs.

Beside these within-subject variations, we implemented four between-subjects *need treatments*. Here, we varied the kinds of needs of both Persons A and B: They either needed the wood to survive, live a decent life, participate in society, or be autonomous (see Appendix A for wordings). In the *survival need treatment*, Persons A and B did not have enough wood in stock to make sure that they survive the forthcoming winter. In the three other treatments, both A and B are guaranteed to survive as they have enough wood at hand. However, they require additional wood for different reasons: In the *decency need treatment*, Persons A and B need wood to prevent an undignified life due to constant coldness in their huts. In the *belonging need treatment*, they need additional wood to participate regularly in social life. Finally, in the *autonomy need treatment*, both need firewood to heat their art studios.

Subjects were randomly assigned to one of the four between-subjects need treatments. Within-subject, we randomized whether subjects started with the high or the low accountability frame. Within each accountability frame, they were presented with the 10 cases reported in Table 2. Here, we further randomized whether they started with the undersupply or the oversupply scenario. Within each scenario, the order of the five cases was also randomized. This random sequence was the same for both the high and the low accountability frames. In total, subjects made 20 allocation decisions, divided by accountability frame and supply scenario as depicted in Table 1.

The parametrization of our vignette by scenario and case is shown in Table 2. Person

The 20 cases (row 4) subjects were confronted with in each need treatment (row 1) consisted of 10 cases with low accountability and 10 cases with high accountability (row 2). Within each accountability frame, 5 cases were presented in the undersupply scenario and another 5 cases in the oversupply scenario (row 3).

A and B chopped 500 logs each in every case, giving subjects a total of 1,000 logs to redistribute between both. Person A and B experienced different quantities of need that changed from case to case while the productivity stayed constant and equal in every case ($A = B = 500$ logs). Person A chopped fewer logs than needed in every case of the undersupply scenario and more logs than needed in every case of the oversupply scenario. Person A's *need gap* (the difference between the logs chopped and the logs needed) decreases in the undersupply scenario (from falling 1,300 logs short in case 1 to 500 in case 5) and increases in the oversupply scenario (from having 50 logs more than needed in case 1 to 250 more than needed in case 5). A's *need share* (the percentage of Person A's need of the joint need of Persons A and B) decreases in both scenarios (from 90% in case 1 to 50% in case 5). In the undersupply scenario, the combined need is always 2,000 logs, which is greater than the joint productivity of 1,000 logs. In the oversupply scenario, the combined need is always 500 logs, which is less than the joint productivity of 1,000 logs. In both scenarios, Person A is always worse off than Person B.

Following Bauer et al. (2020), subjects were asked for their age, gender, and equivalent household net income at the end of the study. Furthermore, we asked them to quantify their support for different distribution principles – namely need, equity, and equality – as well as the importance they ascribe to different kinds of needs, their self-perceived locus of control, and their political orientation, all on 7-point scales (see Appendix B for wordings).

To ensure that subjects read the vignettes and instructions thoroughly, they had to answer three control questions after completing the main task (see Appendix B for the wordings). We limited our final analysis to subjects who answered at least two of our three questions correctly. Those 400 subjects were compensated with 4.90 euros, equivalent to an hourly wage of 9.80 euros. Another 166 (29.12%) subjects were excluded from the study. As announced beforehand by the institute responsible for recruiting our subjects, they were not compensated.³

A's need gap describes the difference between A's need and productivity, a negative gap indicating oversupply. A's need share represent A's proportion of the total need.

Our study was implemented in oTree (Chen et al. 2016) and carried out online in November 2020. The panel provider *respondi* was responsible for recruiting subjects. To promote external validity, we ran the study with a quota sample based on the characteristics *gender*, *age*, and *household net income*. For the respective quotas, we drew upon the *Best for Planning* study of Germany's Society for Integrated Communication Research (Gesellschaft für integrierte Kommunikationsforschung 2019, p. 284, 291). The actual distributions can be found in Table 7 in the Appendix. Our total sample size was $n = 400$.

Given the results from Bauer et al. (2020), we suspected that

- (1) subjects allocate less to the needier person if this person can be held accountable for needing more than the other person, and
- (2) subjects allocate more to the needier person than this person has contributed, and
- (3) subjects allocate more to the needier person the higher their share of the total need is.

Additionally, we assumed that

- (4) subjects allocate more to the needier person if there is a surplus of resources, and

wrong (age: $\chi_4 = 6.400$, $p = 0.171$; income: $\chi_4 = 4.704$, $p = 0.319$; gender: $\chi_2 = 8.276$, $p = 0.016$).

(5) subjects' allocation decisions are influenced by the kind of need they are presented.

Regarding (4), one could be inclined to stipulate a specific hierarchy among the four kinds of needs. Intuitively, for example, needs for survival may seem more basic than, say, needs for social belonging. At this point, though, we refrain from stipulating anything and limit ourselves to this rather explorative conjecture.

4. Results

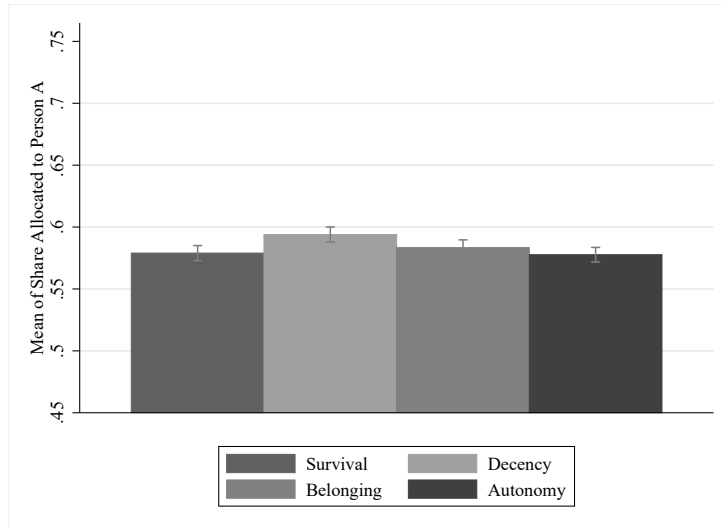


Figure 1: Bar charts of mean share allocated to Person A per need treatment with 95% confidence intervals

Apart from a possible between-subjects treatment effect, we expected that subjects would acknowledge each kind of need as important in its own right. Thus, there should be a tendency to distribute unequally between Persons A and B in every treatment, even though both have contributed the same amount of firewood. This, indeed, seems to be the case, as Figure 1 suggests, depicting the mean share (the logs they receive divided by all logs available) allocated to Person A per need treatment.

The data reveals that the share allocated to Person A differs significantly from an equal share of 0.5 in each of our treatments, as t tests show (Survival: mean = 0.579, 95% CI = [0.573, 0.585], $p \leq 0.001$; Decency: mean = 0.594, 95% CI = [0.588, 0.600], $p \leq 0.001$; Belonging: mean = 0.583, 95% CI = [0.577, 0.590], $p \leq 0.001$; Autonomy: mean = 0.578, 95% CI = [0.572, 0.584], $p \leq 0.001$; one-sample t tests, mean tested against 0.5).⁴

The influence of the need share also becomes apparent if we take a look at the single cases we presented to our subjects. Here, the need share of Person A was designed to

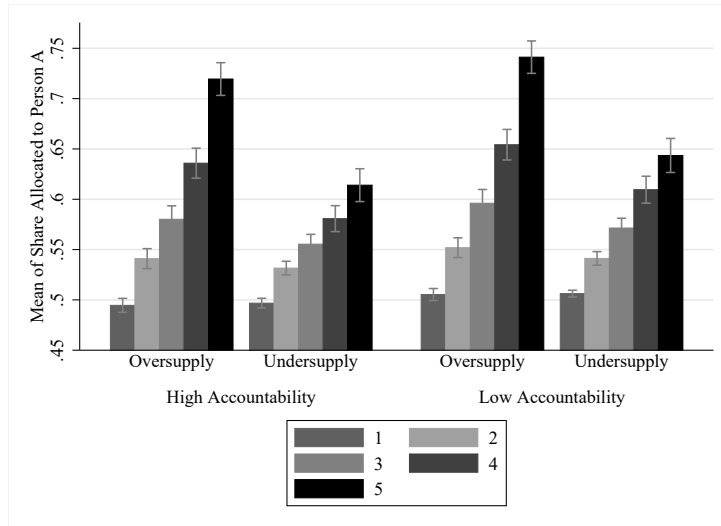


Figure 2: Bar charts of mean share allocated to Person A per case with 95% confidence intervals. Left panel: cases presented in the high accountability frame. Right panel: cases presented in the low accountability frame. Within each accountability frame, cases are split into those from the oversupply scenario and those from the undersupply scenario.

vary from 0.5 to 0.9. Clearly, this influences the mean share allocated to Person A per case, as Figure 2 shows. The mean share allocated to Person A increases from case 1 to 5, correlating with the ascending need share of Person A that rises from 0.5 in case 1 to 0.9 in case 5. This is further supported by the regression analyses reported in Table 3 below.

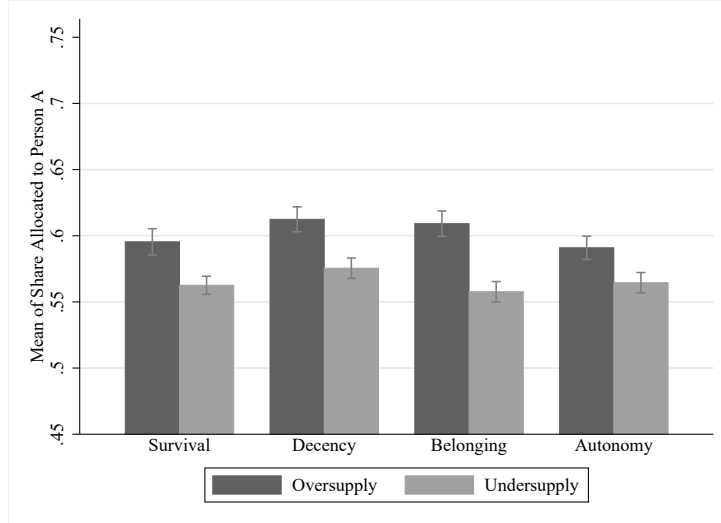


Figure 3: Bar charts of mean share allocated to Person A in each supply scenario per need treatment with 95% confidence intervals

For further analysis, we can break down the data for the different supply scenarios that were introduced. Accordingly, Figure 3 shows bar charts of the share our subjects allocated to Person A in the undersupply and oversupply scenario by need treatment.

Here, t tests indicate that the supply scenario has a highly significant effect on the share subjects allocate to Person A in all treatments. In general, the mean allocated to Person A is higher in the oversupply scenario than in the undersupply scenario (Survival: mean difference = 0.033, 95% CI = [0.023, 0.043], $p \leq 0.001$; Decency: mean difference = 0.037, 95% CI = [0.029, 0.045], $p \leq 0.001$; Belonging: mean difference = 0.051, 95% CI = [0.042, 0.061], $p \leq 0.001$; Autonomy: mean difference = 0.026, 95% CI = [0.018, 0.035], $p \leq 0.001$; paired-sample two-tailed t test).⁵

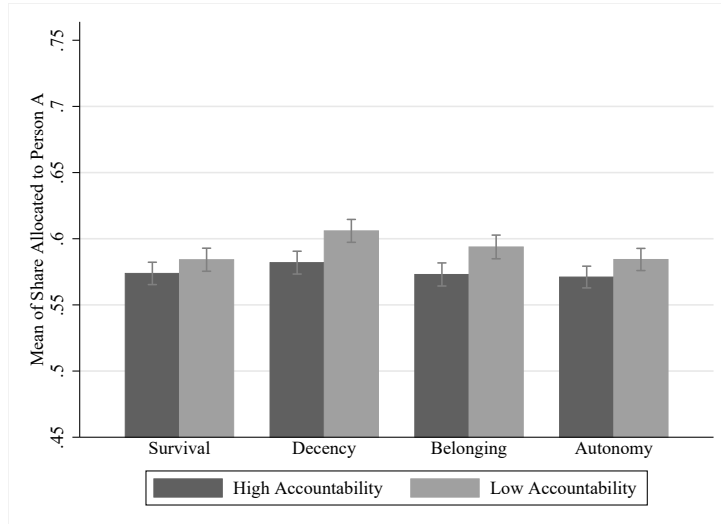


Figure 4: Bar charts of mean share allocated to Person A in each accountability frame per need treatment with 95% confidence intervals

In addition, we suspected an influence of the accountability frame. Here, Figure 4 shows bar charts of the share our subjects allocated to Person A in the low and high accountability frame by need treatment.

Again, we find highly significant effects in all treatments. In each treatment, the mean allocated to Person A is lower in the high accountability frame than in the low accountability frame (Survival: mean difference = -0.010 , 95% CI = $[-0.016, -0.004]$, $p \leq 0.001$; Decency: mean difference = -0.024 , 95% CI = $[-0.030, -0.018]$, $p \leq 0.001$; Belonging: mean difference = -0.021 , 95% CI = $[-0.028, -0.014]$, $p \leq 0.001$; Autonomy: mean difference = -0.013 , 95% CI = $[-0.020, -0.007]$, $p \leq 0.001$; paired-sample two-tailed t tests).⁶ The lower share Person A gets in the high accountability frame is still significantly different from an equal share of 0.5. So even when they are accountable, subjects acknowledge the hypothetical person's need (Survival, high accountability: mean = 0.574, 95% CI = $[0.565, 0.582]$, $p \leq 0.001$; Decency, high accountability: mean = 0.582, 95% CI = $[0.573, 0.591]$, $p \leq 0.001$; Belonging, high accountability: mean = 0.573, 95% CI = $[0.564, 0.582]$, $p \leq 0.001$; Autonomy, high accountability:

mean = 0.571, 95% CI = [0.563, 0.579], $p \leq 0.001$; one-sample t tests, mean tested against 0.5).

Furthermore, we wanted to know whether the different kinds of needs influence the share of logs distributed to Person A. As Figures 1 to 4 already indicated, this does not seem to be the case, which is further confirmed by the regressions reported in Table 3.

Here, Model (1) is limited to dummy variables for the need treatments, with the survival need treatment as benchmark category. Model (2) further includes Person A's need share (0.5, 0.6, 0.7, 0.8, 0.9), the accountability frame (0 = low accountability, 1 = high accountability), and the supply scenario (0 = undersupply, 1 = oversupply). Lastly, Model (3) adds control variables and Model (4) adds interaction terms (reported in Table 5 in the Appendix).

Model (1) shows that none of the treatment dummies is significant. Whether Person A is described as needing the wood to fulfill their survival, decency, belonging, or autonomy needs does not influence the share of logs they receive. However, Model (2) shows that Person A's need share, the accountability frame, and the supply scenario all have a significant impact on their share of logs (estimated slope coefficients: need share = 0.436, 95% CI = [0.410, 0.462], $p \leq 0.001$; supply scenario = 0.037, 95% CI = [0.029, 0.045], $p \leq 0.001$; accountability frame = -0.017, 95% CI = [-0.022, -0.012], $p \leq 0.001$). With each percentage point more of the total need, an additional share of 0.436 percentage points is assigned to Person A. Moreover, Person A receives additional 3.7 percentage points in the oversupply scenario. If Person A is accountable for their situation, though, they lose 1.7 percentage points. Model (3) indicates that all need treatments remain insignificant while the need share, accountability frame, and supply scenario remain highly significant when control variables are included. Finally, Model (4) shows that

all interaction terms are insignificant, except for one.⁷ All models include a Pseudo- R^2

⁷ To further evaluate if the inclusion of interaction terms positively impacts the quality of Model (4), we ran four additional regressions and performed comparison tests. Using the same endogenous variable, a first additional model – Model (5) in Table 6 – contains only need treatment and accountability frame without interaction terms, while a second additional model – Model (6) in Table 6 – contains interaction terms for need treatment and accountability frame. Similarly, a third additional model – Model (7) in Table 6 – contains need treatment and supply scenario without interaction terms, while a fourth additional model – Model (8) in Table 6 – contains interaction terms for need treatment and supply scenario. Performing two Likelihood Ratio (LR) tests for determining if the interaction terms improve the model's fit, we obtained a p value of 0.249 for Models (5) and (6) as well as a p value of 0.009 for Models (7) and (8), indicating that – in case of Models (5) and (6) – the interaction terms do not contribute significantly to a better fit

However, since we are using robust standard errors in our regressions, a LR test must be performed cautiously, and its interpretability is severely limited. Therefore, we also obtained the Akaike Information Criterion (AIC) and the Bayesian Information Criterion (BIC) for our four additional models, which both serve as metrics for model selection, with a lower value indicating a better fit of the model

measure as specified by Snijders and Bosker (1994) for both the individual level (L1) and the group level (L2), i.e., between the four treatment groups.

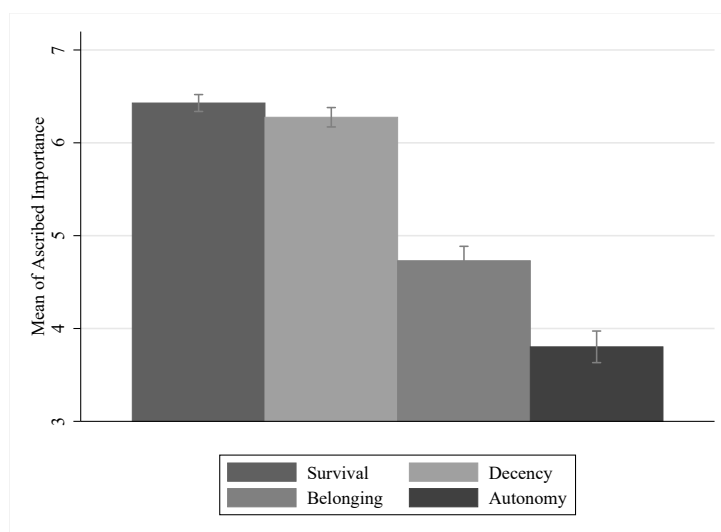


Figure 5: Bar charts of importance ascribed to each kind of need with 95% confidence intervals

Given this between-subjects data, one might be inclined to assume that people do not think that different kinds of needs should lead to different allocations, hence that they all are more or less equally important. This conclusion might be a bit hasty, though. While every subject was only introduced to one single kind of need for the main task, we implemented a questionnaire at the end of our study in which we asked subjects to evaluate the importance of all four kinds of needs simultaneously.⁸ Figure 5 shows the mean importance subjects ascribed to the four kinds of needs in this task. Each kind of need was rated from 1 (“not important at all”) to 7 (“very important”).

As can be seen here, most subjects rated the importance of survival need and decency need as very high (Survival: mean = 6.434, std. dev. = 0.906; Decency: mean = 6.275, std. dev. = 1.037). The importance of belonging need and autonomy need, however, is clearly evaluated lower (Belonging: mean = 4.701, std. dev. = 1.584; Autonomy: mean = 3.783, std. dev. = 1.706). Accordingly, a one-way repeated measures ANOVA reveals a significant effect of the kind of need on the evaluation of its importance ($F(3, 1572) = 351.090, p \leq 0.001$), allowing us to reject the null hypothesis that – in this task – the mean evaluation for all four kinds of needs is equal.

in question. Here, Model (5) exhibits slightly lower values (AIC = -10224.08, BIC = -10175.17) than Model (6) (AIC = -10222.2, BIC = -10152.33), while Model (7) (AIC = -10370.35, BIC = -10321.44) in comparison with Model (8) (AIC = -10376.01, BIC = -10306.14) does not.

⁸ For the following analysis, 15 subjects were excluded because they had one or more missing values for their evaluations of the four kinds of needs.

As Table 4 further shows, pairwise comparisons of all kinds of needs – except for survival versus decency – are significant at the $p \leq 0.001$ level. Hence, we can conclude that – except for survival versus decency – subjects ascribe distinctly different evaluations of importance to the different kinds of needs.

To summarize, our analysis has shown that there is no between-subjects effect of the different need treatments; subjects do evaluate the kinds of needs differently, though, when presented with all of them on a within-subjects level. Furthermore, we have shown that subjects’ distribution decisions are influenced by the neediness of a person, which is moderated by their accountability and the general resource availability.

5. Conclusion

This brief report summarized a follow-up study to Bauer et al. (2020) in which we tested for the effects of need, accountability, and resource availability on third-party distribution decisions as well as for the possible effects of different kinds of needs.

We did not find significant differences in distribution decisions between the four need treatments. This, we assume, is the case because the differences in the rather long vignette texts were relatively small. Presumably, this was not enough to make the different kinds of needs and their implications salient. Our questionnaire at the study’s end gives some support to this assumption. Here, subjects had to evaluate the importance of the four kinds of needs simultaneously on a scale from “not important at all” to “very important”. A clear majority of subjects rated the importance of the needs for survival and decency as very high. The importance of the needs for belonging and autonomy, on the other hand, was evaluated distinctly lower. We take this as an indication that further studies are needed to test the possible influence of different kinds of needs on distribution decisions.

Moreover, we found that subjects tend to distribute the firewood unequally between the two hypothetical persons, even though both have contributed equally to the total amount available for redistribution. This is the case in all four need treatments. In each of them, the (mean) share of the total amount distributed to the needier person is

significantly higher than an equal share of 0.5. Hence, in the distribution task, all kinds of needs mattered to our subjects, and none of them was perceived as superfluous or irrelevant with regard to a just distribution. As our regression revealed, this effect is not only influenced by the accountability frame and by Person A's need share (as we have already seen in Bauer et al. 2020) but clearly also by the supply scenario. In sum, the mean subjects allotted to the person experiencing the higher need was significantly lower when this person was accountable. Nonetheless, even when accountable, this person received a higher share of logs than their initial contribution would suggest. This share was even bigger when there was a surplus of resources.

Consequently, our findings bear some noteworthy implications. First, it is important to note that we successfully replicated key findings from Bauer et al. 2020, even though we slightly modified the vignette, changed the parametrization, and implemented the accountability variation within subjects instead of between subjects. This gives even more weight to the data implicating that laypeople consider the factors of need and accountability when thinking about just distributions. Given our study's new data, we can now confidently add that they also take resource availability into consideration. Unfortunately, our data is less clear when it comes to the role different kinds of needs may play. Here, subjects treated each kind of need as similarly important in our between-subjects treatments. When they were asked to directly compare of the kinds of needs, though, a pattern emerged that shows that needs are perceived as differently important. Clearly, further research is needed in this regard.
