

An Evidence-driven Research to the Transgressions of Geneva Conventions by the Communist Party of China Led Autocratic Regime

Abstract— The "second-generation indigenization" hypothesis of Huntington's phenomenological observations on totalitarianism in Cold War regime collapse subtly portrayed the realpolitik interest groups' political influences with autocracy disbandment processes. The research puts democratization as the premise and globalization as purpose for the analysis, with the cultural anthropological psychopathology & criminological elements of genocide and crime against humanity explained, underlying some of the Communist Party of China (CPC)'s organizational behaviors. With the regionalism purposes & approaches to multilateralism by People's Republic of China (PRC), the end of democratization is leveraged against the procedural means with power politics of declared "democracy". Between quantitative autocratic controls and realpolitik local-regional interest groups, the connotation of democratization in liberal international globalization has either been used for militant purposes or pushed the landscape of regime collapse into realpolitik local groups and autocratic controls in the process of globalization, with a case study on a local branch of Agricultural Bank of China on supply-side hijacking by the State-owned Assets Supervision and Administration Commission of the State Council (SASAC). With the industrial interests imposed on realpolitik local groups, autocratic regionalism becomes of the "best interest scenario" for the realpolitik local groups with psychopathological spread of the criminological behaviors, by the cyber organizational criminal operations correlated with PRC's approaches to international relations and multilateralism through bilateral trade & finance in monetary and currency domains, developed into the digitization of economies with criminological schemes in telecommunication, information, and informatics systems. However, the diminishing autonomy & freedom of the territorial population in turn derogated the real economy that wielded the prisoners' dilemma between autocracy and totalitarianism in a negative sum game deterioration cycle, with the censorship practices by the illicit regimes for propaganda controls sustaining "ideology security". In the democratization process of the dictatorial regime, "second-generation indigenization" is thus mapped to the sectarian interests respondent to dictatorial propaganda generation, other than a natural phenomenon out of autonomy and freedom premises in decision theory. The article recaps the *coup d'état* between Xi Jinping and Bo Xilai before Xi took the autocratic power, and analyzes the human rights situation in the obstacle of democratization and by the coercion mechanism imposed on the mainland China civil society for the militant purposes, with its behavioral spread of censorship to the "internet platforms" in liberal democratic countries by financial interest incentives and avoidance from war threats, whereby military backends in the cyber systems already indicate otherwise.

1 INTRODUCTION

WHEN Bo Xilai was demoted from the ministry of commerce to the mayor of Chongqing, Chinese politics was on the verge between *coup d'état* and surveillance interests. [1] distinguished "between two different types of coups: (a) reshuffling coups that replace an incumbent leader while preserving the power of the incumbent ruling coalition and (b) regime-change coups that overthrow the entire autocratic regime by ousting the leader and the leader's primary support coalition."

Nationalism propagandas for the communist regime exactly aim to oust the latter, so it was only a question of who gets to be the new dictator between the two childhood bully and bullied pairs. Bo's purpose was simple. He ousted all the city and provincial leaders in Chongqing who were not in favor of his power, pressured the Chongqing Television for public propagandas by criminalizing the former group president, and seized the military power of the Chengdu military zone for intimidating his childhood prey by sending the troops to Zhongnanhai in several occasions. However, deeper interests in the surveillance state [2] have had still been with the military-industrial complex. Or in another way, nationalism reinforces the realpolitik territorial interests. For the history of Chinese civilization, the public difficulties in imagining a democracy without a ruler is the natural tendency of buying into the propaganda lies. Populist financial interests hence accomplice with the realpolitik industrial interests, shaping an autocratic cycle of military expansionism.

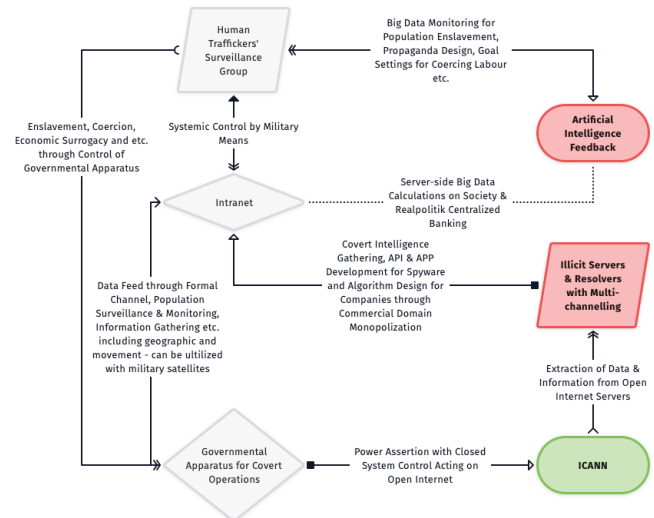


Fig. 1 The conceptualization from observation and evidence on the criminological organizational behaviors in the cyber domains.

Albeit it is a *de facto* autocracy for PRC with a visible answer, bridging knowledge and information gaps between democracies and undemocratized regions may still shed new insights with the merchantalized liberal and neoliberal democratic institutionalism. As conceptualized in figure 1 [3], metadata trade still lies with the core macroeconomic, monetary, and ideological interests of the autocratic power. The ideological designs of Xi and Bo was no different with crimi-

nalizing opponents and gas-lighting through media, except for the technological subtleties in efficiency through the satellite telecommunication services that can be traced back to the initiation of the "Great Firewall" [2]. As was evidenced in [4], the totalitarian eugenics "marriage law" of PRC is the source of stigmatization by militant coercion not only for LGBTQIA+ but heterosexuals alike, its coercion mechanisms through financial institution & compartmentalization are the basis for global financial crimes conducted through backend and governmental apparatus [5]. In the political reforms during the 1990s after the 1989 Tian'anmen Square Massacre seen in figure 2 [6], CPC leader Deng Xiaoping specifically put in a term limit in the constitutionalism of PRC in preventing the structural dictatorial constitutionalism from becoming autocracy if not empirically changing it entirely, which was formally abolished in

2018 after Xi Jinping eliminated Xu Caihou and took all military power, with regard to Jiang Zemin's "Shanghai Gang"'s geopolitical interests in the Chinese macro-economy and ne-omercantilism [7].

The Geneva conventions do not exclude rational war, but prevents genocide. The Westphalia order of war, or peace thereof, puts genocide in crime against humanity for the unjust means and causes of war. The research was conducted in the spirit of the Universal Declaration of Human Rights (UDHR), and the criminology judgements in the spirit of the Geneva Conventions & Roman Statute. Technical analysis on the organizational criminology [3] was conceptualized with comparative topological structural analysis. In the severe breaches to fundamental human rights, the common parlance the CPC use has been the totalitarian reinterpretation of the Westphalia order as "non-intervention in domestic affairs", while using nuclear threats on the global society for defeatist dominance, which in substance denies the universality of the UDHR. The CPC have been using language arts in the global communication system with psychopathological threats for relative power gain through unilateral disarmament claims on the other countries and parties [8], with a geospatial construct of the Communist propaganda systematic design established since the Cold War [9]. While the cultural and economic rights and human rights have often been inverted by the CPC discourses on the civil society for indigenous propaganda purposes [10], creating an illusion of domestic and international duality behind the server and topological systems [3] for militant supply side hijacking; its overall behavior is not without cultural anthropological roots.

The research adopted a mixed method of cultural anthropological analysis, organizational behavioral observations, original category analysis, and social survey case study in analyzing the global derogation of human rights regardless of the partial developments and efforts by major democracies and regional civil organizations. The cultural anthropological analysis mainly studied the Chinese civilization's cultural psychological roots & origins of genocide and crime against humanity especially with its currently heightened cultural revisionist behaviors [4], and organizational behavioral observations on its operational backends. The original category analysis is explanatory for the party territorial coercion objects behind the systemic designs & label systems, and the social survey case study on the details of how such coercion mechanisms have been instituted with modern technological developments. The research results with some of the modified behaviors observed in the in-person social interactions and social media interactions. Its behavioral proliferation into the social media based in democratic countries has also been observed, analytically through the economic incentives with the supply side hijacking and monetary apparatus.

Even though PRC is not a signatory party to the Roman Statute and apart from the historic transgressions to the provisions of the Geneva Conventions by the Maoist dictatorship, the militarization of educational institution & human rights work violated International Humanitarian Law rule #6 "require distinction between combatants and civilians, and between military objectives and civilian objects" and rule #26

"protect to the work of humanitarian relief" [11]. With the evidenced proliferation in Beijing city [12,13] by photochemistry method with quantum chromodynamics applied in the cinematic arts [14], the violations on rule #1 "prohibit the use of chemical weapons, bacteriological weapons, poison...", rule #4 "prohibit means and methods of warfare which are inherently indiscriminate or are of a nature to cause superfluous injury or unnecessary suffering, or widespread, long term and severe damage to the natural environment", and rule #6 have been convicted [11]. As can be seen in figure 3 [15], after years of reporting on particulate matters by American Embassy in Beijing, the radioactivity in the air with heat island effect has been prominent, along with contamination of drinking water [12,16].

The fundamental transgression on rule #6 of requiring "distinction between combatants and civilians, and between military objectives and civilian objects" and the inverted use of rule #8 [11,4] by placing civilian and civilian objects, such as civil economy, "against the dangers resulting from military operations" in order to protect military personnel and military objects has been the purpose of totalitarian politics and "cyber sovereignty" claims. Social surveys have been conducted with the financial coercion posed on me with the "cloud trials" [17]. Backend manipulations between numerical currency values and material accountancy were also noticed [18]. As was evidenced with [4], "the National People's Congress Standing Committee is ... under military coercion ... by the CPC Battle Assembly Bureau, misguidingly and collectively labelled as the "United Front Work Department of the CPC Central Committee" (UFWG), the criminology of the covert militarization of the education institutions has been the result of using the civil economy for military financing. The broadcasting code [17] served as the preliminary evidence for the deeper semantic constructs of artificial intelligence (AI) cyber aggression to fundamental human rights [2,12]. The initial symbolization of the nuclear semantic threats was communicated through the nonproliferation, arms control, and disarmament artwork [19] with media-psychology based alerts [20,8]. Besides the discrimination of LGBTQIA+ by the regime, the indiscriminate psychological attacks violate #9 of the rules [11] and the specific harms on LGBTQIA+ may constitute as crime against

humanity or genocide [21].

With the psychological conclusions in somatic psychology for the gender & sexual minorities of the groups [22], emotional phenomena should be respected and the freedom of expression is necessary for democratic formation, with the notice on & noticed impact from the dictatorial AI psychological distortions [9,10]. From the cultural anthropological analysis, incitement and human conscience need to be differentiated in human perceptions, and should not interfere with the spirit of the UDHR. The diagnostic cultural anthropological analysis in the methodology section portrays the criminological incentives in the Chinese civilization cultural psychopathological roots & origins, compared to the principles of Geneva Conventions and the Westphalia order of peace, or war thereof, on the scientific basis of war against genocide in the preservation of

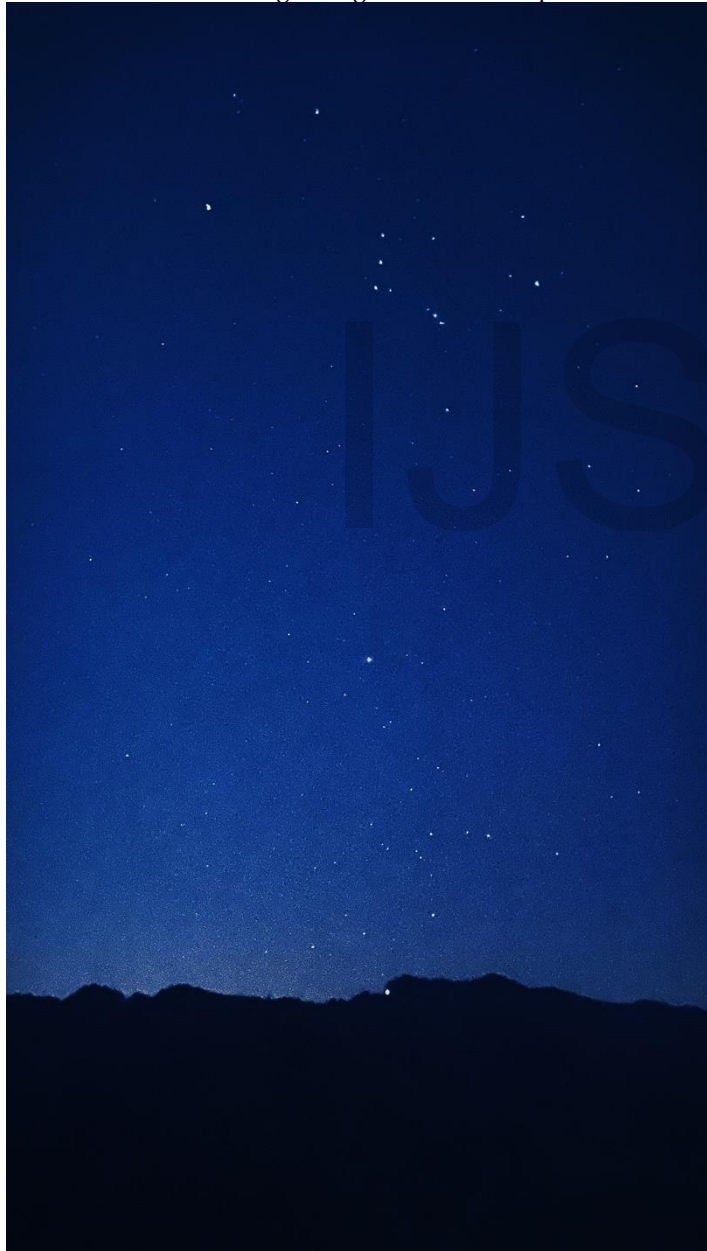


Fig. 4 Particulate matter generation in Chongqing shining together with the night sky, iPhone 6P with Enlight APP Sep. 30, 2021. [15,13]

the fundamental human rights. Furthermore, the research suggests that the intrusion to the value system starts with the mental and psychological health transgressions. With democracy fundamentally a bottom-up system of human social cohesion, the linguistic arts used in the cultural disguise of semantic spread in the telecommunication, information, and informatics systems have the destructive potential for democracies and democratic processes similar to the mass psychological phenomenon observed in the case studies. From the principles of rational behavior induction, the cultural anthropological explanations of organizational behaviors can be a mere strategic behavioral design in organizational communication without revealing organizational operational details and the decision mechanisms behind those operations. The cultural anthropological analysis concludes that the failure of the development in scientific methods is the cause of the cultural civilization collapse of the ethnic group that the CPC regime has been trying to re-institute as its "domestic policy" for the purpose of controllability [4].

Continued from the previous researches since the author's graduate research [23,24], where psychoanalysis was used to counteract the linguistics calculations of the dictatorial-ontological closed network with a double-copy dissertation in preserving the syntactic truth of the cosmological theory [25,26], in spite of the human trafficking during the research process [12]; the Question Order Effect [27] in quantum psychology was applied in the qualitative evidence gathering process, partially overcoming the visual coding process of the dictatorial AI sensual incentive generation [28,2]. It is with this regard, the dictatorial psychopathological penetration has extended to outer space [29], and triggered the defensive-responsive actions of the cisgender heterosexual competitions in quantum communication [30]. The Eutelsat's natural decay design is estimated to be a safe procedure. In further analysis between large-scale chip production in Chongqing with regard to the closed ontological framework [24], *figure 4* shows the hydroelectrolytic product of the pollution in the humid geological environment during the day [15].

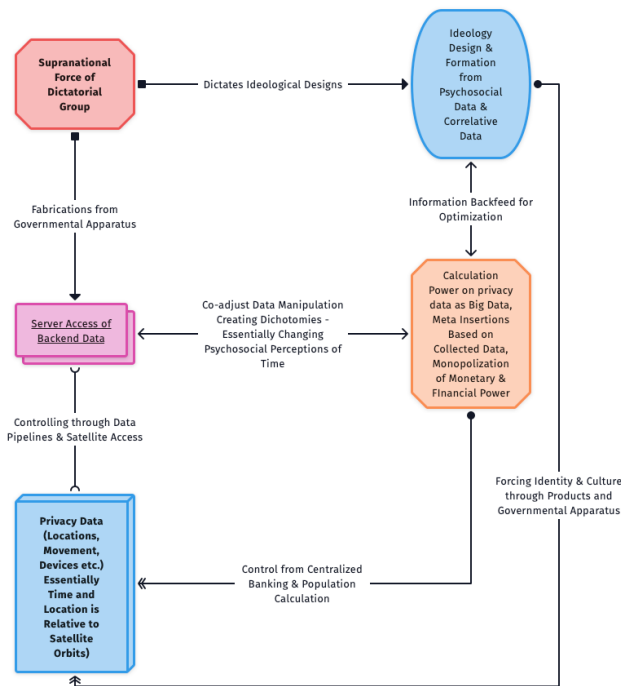


Fig. 5 Flowchart on the Dictatorial Group Supranational Force's Use of Privacy Intrusion [3].

With the militarization of academic institutions by the funding body of National Natural Science Foundation of China evidenced in [4,31], the military intentions in the designs and executions of the Quantum Experiment at Space Scale (QUESS) which contaminated the thermonuclear environment of outer space had been anticipated [18,30] for the empirical research [32]. The regaining of autonomy was achieved by the anthropological psychoanalytic experience [28] and the application of quantum transference which further aided the self-healing from Stockholm syndrome and Post-Traumatic Stress Disorder [29]. Due to the notion of keyboard trafficking that contributes to the real-time generation of propaganda incentives [2] seen in *figure 5* [3], and with their satellite backend accesses with the similar technological developmental patterns to the USSR [9]; semantic analysis between cisgender and sexuality was performed, specified in the methodology. The financial crimes conducted for military purposes with semantic threats disguised in culture "soft power" in the cinematic industry [4,22] were informed by the social surveys during my work as editor in the industry with relation to the off-shore

People's Liberation Army (PLA) military spending [23]. The displacement between autonomous cultural and religious freedom, and the imposed semantics for ideology & financial purposes after the "Great Cultural Revolution", sheped the new phenomenon in the artificial "second-generation indigenization" described in [15] as "contributed to an inner sense of guilt with a strange belief that the Buddhas can wash away their sins, when the Tibetan Buddhism has been under constant prosecution without any public voices for justice nor private material support". The Tibetan Buddhism's faith not incorporated into the CPC governmental apparatus for population control and financial gains [15] is the reason for the stigmatization of the faith group. From a criminological perspective, the forceful party-interest impositions on religion violate *rule #10, #12, and #22* "require respect and protection of medical personnel and religious personnel" outlined by [11]. Even if the contamination of thermonuclear environment of outer space does not have evidence for the direct intention, its consequences have severely transgressed *rule #4 to #9* in [11], with specific consequences in indiscriminate attacks with means and methods of warfare which are inherently indiscriminate or are of a nature to cause superfluous injury or unnecessary suffering, or widespread, long term and severe damage to the natural environment; with environmental modification as a method of warfare which maximized the probabilities in incidental loss of civilian life, injury to civilians or damage to civilian property [12,18]. After the initial notice on the harms and potential threats from the electronic warfare [12], the victim case was noticed and interviewed with twice harms to biological health from 2019 to 2022 by sonic waves [34]. If the China's communist constitutionalism's denial of

private property, hence civilian property was *de jure*, its global impact put the whole nation's population to be military objects or the private properties of the global economy to the CPC assets.

2 METHODOLOGY

The research questions into the intrinsic psychology of holo-caust denial in context of the mainland China regime on the June 4th movement in 1989, which is analogical to antisemitism. [35] witnessed the benign 'period following the the Cultural Revolution ... more freedom for the Uighur people ... as though we had an opportunity to secure a democratic future ...'. Recalling the imminence of the holocaust in psychoanalysis, [36] stated the patient's innermost sense of reality while "everyone was afraid to awaken the dragon or to acknowledge the presence of this Ego that was armed to the teeth in defense against the world of annihilation." Bringing the psychological professional communities to the Nazism identification is not a single historic phenomenon but also organizationally construed by the UFWG of CPC [4]. With the genocide happenings with seamless individually targetable mass surveillance [37,2], the methodology adopted seeks to reorganize the phenomena of psychopathological spread to the organizational behaviors and sources through its incentive structure designs. With the rational parts reflected in the technological and mechanical systems [3], the cultural anthropological analysis seeks to diagnose the breaches to the system of values underlying the liberal international institutions [38].

From a natural science perspective to the anthropological development of geological human scatterings, the disjunctions of original categories of the natural epistemology to Communist political epistemology on an institutionally indoctrinated basis are observed to be one of the prominent characteristics of its ideological designs. The geologically deductive tracking of human activities and labor output are observed to be the epistemological original categories of the CPC, explaining its cultural anthropological counter-transference in the ideological domain. Co-evolution of the original category to the market economies is observed through governmental apparatus agency surrogated by civil economy [23]. During the social survey and case study, the observation was corroborated to be correlated to the State-owned Assets Supervision and Administration Commission of the State Council (SASAC) acting upon the central banking system. It means that even if with a natural epistemological construct, the financial incentives instituted numerically with the central banking can still effectively exert control through the data system, especially with personalized mobile devices and "integrated development" discourses [23]. The surjective model of financial incentives injected by autocratic and dictatorial ideological targeted input and commercial banking data collection in big data analysis [3] constitutes the "degree of freedom loops" of the crime correlations.

As the criminological designs of the systems in the mainland China territories put sensual experience into cultural narratives with calculations in the backend counter-looping the civil society's human behaviors, the social surveys and case

studies adopted a "freedom from fear" principle in the social interactions. Even though fears in the professional positions were expressed by the instituted coercion mechanisms, the ideological hope behind the veil of ignorance was observed, which is explainable by the "electrified monkey" experiments with corrections to the ideological input of relative gains with ideological designs sustaining the sensual calculations of relative gains reinforcing the Stockholm syndrome in professional positions. Such phenomenon is consistent with Eichmann's testimony in the separation of familial identity to professional identity [39]. Even though the institutional correlations were drawn on SASAC during the case studies while the clerks in the Agricultural Bank of China (ABC) tried to help with transferring \$ 111.10 from my account cash to my America based banking account as international settlement and not remittance, which is operable with the Bank of China; with a good faith in the humanities the bank clerks tried to ensure me during the interactions, where they also tried to preserve the observations with what they see daily behind the counters, I only pointed out it has been associated with military spendings before I left. The case studies and survey were performed when I entered the local bank asking for international cash transfer while the clerks received a phone call asking if there had been any international transfer that day, and while the clerk asked me the use of the money, I told her that I was researching into the issues since before the Trade War and the money was intended to buy books from the sources outside of the censorship system. The social surveys hence are regarded in the context that the banking clerks exercised their negative freedom with the researcher.

In the technical evidences gathered empirically, the qualitative data are gathered between the years 2009 and 2022. The imaging data mainly used photochemistry method applied with quantum physics with the cinematic detection plates. The method was conceived during my undergraduate studies with the notice on chromodynamically coded electromagnetism with imaging plates from post-production software [14]. Even though the individually targetable mass surveillance was already known to me at that time [2], the metadata capabilities and correlative financial calculations in relation to psychological manipulation & AI calculations were only drawn during my graduate studies in School of Economics and Management in Communication University of China (CUC), with organizational behavior observations & analysis. Its correlation to dictatorial psychopathology was drawn from 10 years of cinematic industrial experience [40] in the closed ontological network [2].

With respect to the inherent autonomy of the persons even with the nationwide suppression of fundamental freedom, the data collected are normalized in the "as is" condition. Without the backend access, the subjective and objective-inference approach was used in analyzing the data to the structural conception of the power operations by military means that has been published in the conference proceedings [3]. The collection condition is under ongoing human trafficking and cyber trafficking of myself by the systemic operations of the PRC-CPC-PLA dictatorial instruments [2]. The data were collected with the Nietzsche philosophy of retributive justice [28] under

power imbalance and least evil for greater good [41]. The data evidences the empirical facets of human rights violations with transgressions to the Geneva Conventions. In the institutionalized context of imposing militant identities on the gender & sexual minorities, the theft of identities with governmental means to the malicious uses of the dictatorial regime power is among the criminology behaviors [3]. No historic justice is envisioned for the LGBTQIA+ persons without the dissolution of the dictatorial regime. With the covert informatics approaches to currency by military controls, further monetary collapse and cyber security complexities have been anticipated, and are anticipated with the regime choices of arbitration over justice, which will cause more severe public mental & psychological harms. The defense departments and industries relying on cybernetics & cyber networks can benefit from the raw evidence materials in presenting and demonstrating the harms in mitigating the peripheries of psychopathological epidemiological spread [29], which can also be associated with digital imagery and video satellite designs.

The use of civil economy and civil population in instigate crimes with regard to the evidence's connotations [42,22], transgresses the Geneva Conventions. With the militarization of the gender & sexual minorities human rights purposed work, the cisgender heterosexual genocide intentions on the sexual & gender minorities are evidenced. The intent of enslaving the sexual & gender minorities quantitatively and uses of the civil population for human shields for the PLA is implied, apart from the further sociological, psychological, and mental stigmatization thereafter. The use of media contents for forceful identity indoctrination through targeted propaganda systems have been behind the criminological motivations of the National Radio and Television Administration & China Netcasting Services Association [23,2]. The data evidence analyzed are composed of the original production project archives, and diagnostic surveys in the power and ideological structure of the PRC. The original project data composed of two parts, the part of the works of the class, and the part of individual files that were altered in the last steps of the post-production process. In the specific sexuality psychoanalytic survey data, I tried to confirm if the account was a regular user of the gay social media application (APP), or covert PLA military surveillance account with a fake profile. With all the interactions, it was confirmed that it was a PLA targeted surveillance account, with rude expressions on my astronomical and cosmological research underway at that time, [23] which was also under surveillance. The consented NASA's Eyes keyboard monitoring for security concerns [2] could have assisted in deterrence. Even though large portions of the evidence from the 2019 human trafficking harm were lost or tampered by China Academy of Sciences' associated companies, the peripheral evidence still reconstructed that event [2]. Since the CUC academic staffs have knowledge and personal judgements on the current issues, including their knowledge about me from the school days, I reported on my research and issues surrounding our graduation co-production with my marriage process [17]. Before the publication of the article, I summarized my currently published research and this piece to the persons involved in the original production for human rights

protection agreement on the publication disclosures, or if there is any objection on my current action, no replies have been received till date.

The investigations conducted adopted a dialectic method. No design nor experiment were involved in the process. This is a real situation. Apart from my faith on my marriage in detaching my psychoanalytic mental resources from analyzing targeted propaganda and looking for scientific evidence refuting them, the detached mentality from the propaganda defense to active research in outer space affairs assisted in a more holistic approach to the analysis of low dimensional quantitative propaganda generation machinery [23,28]. The reasons of refuting their illicit claims were explicitly expressed wherever possible, as seen in the data. The *Evidences on Financial Coercion.zip* file contains the machine-generated threats sent through telecommunication means, and some dialectic process I made with the assigned lawyers of the companies involved. Most of the numbers are not allowed for reply and the "cloud trial" without jury, indictment, lawyer, and any other procedural justice involvements are evidenced. The *Psychological and Mental Torture with Male Genitals.zip* file documented the dialectic process in determining the authenticity of the fake profile account [2], with social theater approach in teaching what is love and family instead of the phishing evils. The subtle hints to the psychological coercion on contour with male genital are evidenced [17], noticing the contoured genital's lack of chest tatoos compared to the fake profile's body features. In the *IMG_7749.jpg* to *IMG_7771.jpg* files, my reports and communications with the undergraduate peer group with some professors in it are presented in the necessities of advocating the change of Courts' wills for honoring the Roman Statute in the territory. The *de facto* war crimes [18,41] evidenced were presented to the group.

The work is conducted with the spirit of the UDHR and in the spirit of the Roman Statute. The participants have been fully anonymized except for the perpetrating entities' unilateral coercion and threats, and the stolen identity profiles that can be further investigated into. The research is exempt from ethical committee approval for the special circumstances of institutionalized coercion mechanism in the nation-wide education system, which is also among the elements of the criminal conducts [12]. Included in the data are also the event of privacy transgression. The metadata behind the dictatorial ontological constructs have not been able to be acquired for the evidence purposes, apart from the dialectic processes with the human traffickers. The real persons of the CUC involved in the dialectic processes are possible to serve as witness and testimonials. The UFWG and PLA are behind the satellite operations of the AI and metadata constructs.

2.1 Cultural Anthropological Analysis

Comparatively from the Western civilization's democratic trust polity formation since ancient Greece, the Chinese civilization developed from the period where The Burning of Books and Burying of Scholars [43] built an absolute authority of measurement centered towards the imperial ruler in the Qin Dynasty, with paper money included. The tribute system underlying the cultural anthropological psychology of space to

the bio-temporal extensions of the ruler's measuring apparatus is consistent of the territorial cultural psychology in ethnic identities [44]. In maintaining such unitary rules of measurement, the deprivations of individual subjectivity in bio-temporal measurements must be in place, underlying the incentives of the Burning of Books and Burying of Scholars [43]; or the extension of bio-temporal necessities in such measurements, which in the ancient technological environment was polygamy in geological distributions. The latter was developmental to the modern & contemporary methods of totalitarianism with Chinese characteristics [45] with ethnic cultural psychological assertions through the extension transference processes [46]. Unitary standards and subcategories are an intrinsic concept to the modern technological manifestations to the ancient realpolitik order of Chinese characteristics through institutionalism. Instead of a liberal political practice in education and democratic formation, the cultural linguistic formation of totalitarianism through double contract is characteristic of the modern cultural anthropological "center and periphery" system of the "central government" of mainland China with the conceptualization of [45]. In the efficiencies of calculation and arrangements, the time differentiation is through the ancient material culture of medium symbolifications. The printing & mint media in ancient cultures gradually lost its efficacy in the modern & contemporary technological developments, however, mobile computing and programming given its physical measurement precision with geostationary satellite designs [9] can more effectively implement the server-side center construct with less visibility from the user interfaces. With metadata labels directly associated with resident cards & passports, the labor values of population can be easily calculated against time series anchored to the center of the calculative constructs with technical models specified in [3]. Computational linguistics gathering of data metrics can thence either be vectorized to local geo-deductive institutions or with retrogressive analysis returned to the central criminalistic organizations on the absolute gains, whereby the local realities can be effectively reported back to the "center" for relative distributions of criminal gains, politically coined as "redistributive justice". Such power political and realpolitik concept shaped the dissection between the academic "scholars" and the military "guards" to the feudal system equivalence that the CPC swore to be "revolutionary against". Furthermore, such extrapolation model is explicitly defined as crime against humanity by the Roman Statute with calculated expansionist models of government structures between marginalization and instigated criminal behavioral rankings to the central organization [2,35].

The military psychology maintenance, hence, is differentiated with designs to the "thoughts" of the CPC cadres with desirable responses picked from institutions and education institutions included. This model is consistent with the ancient imperial Chinese education & examination designs with propaganda indoctrination for incentive building in the object-specific hierarchies of predominantly heterosexual male Adrenalins of preoccupation in its organizationally reinforcing imperial expansionist behaviors. A dichotomy is thus created between the humanity of the individual and the incentive sys-

tems of punishment-award ranking. Since the military line of organizational criminology does not necessarily require non-action-based communication for its hierarchical structure of obedience, the designs in computational linguistics orders with exogenous encryption models & cryptography specifically tailored to the dictator thus became the purposes in telecommunications [2]. The ethnic specific marginalization on the Uighur ethnic persons with forced acculturation was mapped to the dictatorial Machiavellian psychopathology through cultural anthropological analysis [10], with a gender & sexuality specific exclusion principle for gender & sexual minority human rights protection in the mean time [28,29]. As the UFWG samples group leaders for surrogated controls on social & organizational groupings, the sampling method of totalitarian coercion can hence be deductible to the basic units such as biological familial ties with the Hukou documents [23]. The same organizational behaviors were observed in the specific case study in *section 2.5*, where every transaction made by the local bank branch was recorded by the fingerprint of the banking clerks and local branch managers. Declaring "democracy" through the military head thus became the tradition of the CPC regime since Mao Zedong, with cultural propaganda building on the civil dependency on the military with coercion semantics, shaping the heterosexual cisgender male centered construct of "marriage" "law" in mainland China, where biological childbirth of women became the "units of family" for dictatorial extrapolation of statistics for "policy" "decisions" such as the birth control "policies" according to the needs of war and agricultural outputs [23]. The consistent methods of extrapolation through all the more detailed data collection further put the resources to the catering of power ambition of the autocratic dictator, and the delusion of being a "leader" of a "global power", with the extended cultural psychology of the tribute system extended to outer space races. Since linguistic texts as matter is culturally inherited by the anthropological developments of "Chinese governance", texts as matter and action are especially the case of the organizational criminology, with controllable intercivilizational concept variability for ideological degrees of "freedom" [47] with cryptography backends. The anthropological cultural psychology building also underlay the necessities for a closed internet system with the "Great Firewall" and monopolization of the Internet Corporation for Assigned Names and Numbers (ICANN) for unitary information gathering & currency surrogacy in market economies [4,3]. The cryptography necessities for sustaining such ideological designs thus incentivized the building of the Micius satellite [48].

2.2 Original Categories

While the original categories of the Chinese civilization have been unified during the Qin Dynasty for resource monopolization after massacres of scholars with other views, many of the ancient civilization cultures and knowledge on astrology and geology were lost. Therefore, during the wars between the CPC and the then governing party Kuomin Tang (KMT), the utilization of cultural propaganda by the USSR designs [9,45] became the CPC realpolitik strategy on hijacking the supply side. Its original categories from agriculture to

industry are typical of the commercial banking lines under the centralized banking and SASAC. With the later industrial occupations, policy banking has branched with geopolitical interests with Russia such as in the South China Sea [23]. However, its strategic reserves and party control on the central banking tie the declared state banking system with the militant "policy" banking together with RMB. While censorship mainly means the silencing of certain voices, the "ideological security" not only mean the semantics on the military command lines, but also the "unification" from the anthropological mentality since the Qin Dynasty. This is also one of the reasons that the civil society and scholars in mainland China often use those particular periods of ancient Chinese history in communicating the current situations of the communist structural dictatorship & autocracy with imperial behaviors.

The linguistics and computational linguistic designs in the top-down language coercions hence shaped the party-line operations and civil society line of incentives through the cultural psychology from ethnic anthropological origins, which also conforms to the landscape of geology in the territorial spheres [15]. Such languages can be further translated into multilingual incentive extensions typical of the works by the CPC Compilation and Translation Bureau, which poses a danger to the interpretative results in computational sociology [10,3] and public mental & psychological health [28,29]. Even though making the civil society more accustomed to the ontological designs has been the purpose of many of the CPC institutions' goals with divisions of operations, the fundamental realpolitik necessities behind the purposes typical of the "Beltroad Initiative" still scatter patterns in the entity branding systems by the Maoist dictatorial ideological thoughts, analogical to the natural epistemological franchises such as Continental Hotel. The Ministry of Industry and Information Technology of PRC, therefore, continues to apply the anthropological psychology of the Qin Dynasty imperialism in measurement and quantification in the realpolitik and ideological semantic calculations being and to be distributed with telecommunication branches [48], and with economic and financial incentive calculation capabilities with the banking systems in digitalization and mobile computing for further targeted & targetable precisions. This explains the infrastructural needs and chip productions of the regime regardless of the environmental & public health harms. This also evidences the intends of genocide and crime against humanity behind the Micius satellite [48,18].

By using cultural anthropological incentives as ideological frameworks, the sense of superiority of the dictator among human development is implied psychologically, with presumed controllability on the wider population by such designs. Within the sphere of supply side controls, propaganda and propaganda in cultural products reinforcing the civil society's reliance on the PLA are predominant, which is also the military head's hierarchical advantage reinforcing the civil society coercion [2]. It asserts the logical premiss on the civil society for cognition distortion and psychological distortion, underlying the mass psychological helplessness underlying the Stockholm syndrome, and fascist behaviors under the consistent exposures in professional settings and controlled media spheres. Since all major companies are deployed with CPC

branches, the reinforcement of behaviors on a daily basis ensures the human behaviors & operations are conformable to the information & telecommunication systems by the review of the dictator and dictatorial autocratic group. With labelling system, more dynamic designs based on the dictator's needs in realtime can be possibly implemented, therefore, explains the similar situation in the Nazi identification problem [36]. With more than a decade of development since the mainland China "Reform and Opening", the "Internationalization of RMB" has replaced the "Nazi identification" internationalization scheme of the historic construct. The rationalization of such schemes by evidence, and the "you only live once" countertransference on the dictatorial psychopathology [28], implies the justification of rational war against genocide & crime against humanity, not only for the "second generation" [36]. It is exactly by reverting the natural epistemology on the large scale with technologies imported and then reverse-engineered to the satisfaction of the dictatorial psychopathological needs has the mass psychopathological behaviors led to the thermo-nuclear contamination of outer space [18]. With the psychopathological variations *ad infinitum* [29], no further psychoanalysis on the original categories has been conducted. However, new forms of incentivization apparatus still need to be mindful about.

2.3 A Posteriori Analysis

The data is the director's project archive on the undergraduate graduation co-production, *The Lithosporic*, from the 2010 Directing (Editing Art & Technology) in CUC [49]. With the political economy inductions upon Brexit and the Trade War, and after the literature research on the cultural revisionist dictatorial semantic structures of PRC [40], analysis on the project archive [17] was performed. In the cinematic productions with the directors' original intentions on transgender human rights, the unwanted broadcasting codes of technology transfer was found in the project archive files that was deleted in the final version of the film. I neglected the details at that time because it was irrelevant to the directors' purpose, and only asked the editorial department to delete that. I changed the story-telling structure as the leading director to focus on the social identity and gender transition phases of the main character, with his conflicts with the malicious social environment and dramas between his identity and first love. Apart from the broadcasting codes on technology transfer, the translated English subtitles for university Digital Video Disk (DVD) archive from the director team were found to be altered from the original transliteration of the line scripts, such as "surgery" was changed into "operation". The director's work files evidence the original intentions and human rights purpose of the work, and detailed how the scenes were shot and produced, including the producers' budget files on the student work. The files being altered in the contents can be used for retracting analysis on the server-based and cyber-based public mental & psychological health epidemiology on the gender lines of stigmatization through the dictatorial AI network in the signal traces of dictatorial control chains [9,12]. The department head Yue Zheng reminded me to keep an archive of the work out of concern upon graduation, and with my inquiries between 2018 to 2020,

she further corroborated that the work's archive was not in the Academic Affairs Office of the university.

The original production project for the *a posteriori* analysis, used AVID Media Composer for post-production, and Photoshop, Microsoft Office, etc. for production works. The archive project used Adobe Encore for the *.srt* file, and the compromised English subtitle in *.txt* file with the *.srt* file are evidenced in the workflow. The background *.wav* file evidenced the broadcasting code that can be associated with the subtitle files for metadata manipulation in university administrative backends or the UFWG in their individually targetable mass surveillance timecode & timestamps [42] for ontological calculation on the measures deliberately defined in [21] "inflicting on the group conditions of life calculated to bring about its physical destruction in whole or in part, with consequences in causing serious bodily or mental harm to members of the group", evidenced in [4,2]. The counter-surveillance surveys used the Chinese company-run gay social media APP Blue2, and WeChat with corporate holdings backends. The report and discussions to the undergraduate community consisting of approx. 20% of lesbian, gay, bisexual, and transgender (LGBT) members and used WeChat as well, for reminders on the inter-personal defense on personal safety.

The "01" to "07" numbered *.mp3* files are the actual music adopted in the final version of the production. The *Background - "Broadcasting" lianyi.wav* contained the information on technology transfer that was never designed by the production groups of the students. The *List.txt* file in Simplified Chinese encoding documented the music files with the *mixdown.mp3* file documenting the final version of the audio file for the film. In the *Director Works.zip*, the office works of the directors are documented in their original forms, and the *project.zip* file documented the AVID Media Composer post-production for the film. The version being inserted with the broadcasting codes cannot be opened on commercial device, possibly for manipulative encryption insertion. In the subtitle *.txt* files, the simplified Chinese subtitles remained the same with the original lines. The English subtitle versions contain the altered English texts with different encoding. The *shiban.eng.srt* file was used in the *DVD.zip* files that contain the Adobe Encore project for the DVD disk image archive originally meant for the university Academic Affairs Office archive.

The data evidence the institutionalized criminology by the CPC with its governmental instruments and PLA by cyber espionage and illicit "cyber sovereignty" claims [4,3]. Further bottom-up strategies for decentralization and democratic formation from the technical interruptions can benefit from the cases in preventing further harms upon the public mental & psychological health. The original subtitle version has been recovered for the spirit of the human rights orientation of the work. The graphical abstract has charted the domain-data-information constructs of the dictatorial human trafficking and surveillance schemes. The patterns of the crimes are consistent with the "Belt Road Initiative" in generating commercial "cultural products" in propagating a Sino-centric "cultural soft power" in the Asian sphere with a dictatorial totalitarian backend, which constitute public mental & psychological health aggression [29]. With the evidence of the data, further sup-

porting experiment modeling can be in place with the price market in relation to the geological marginalization of geopolitical realpolitik. The "cultural products"'s spread in the markets can be modeled against the third sector with purchasing power parity across country domains. Human rights lawyers can use the data for technical evidence in analyzing the intents behind these operations in further accusing the genocide against the gender & sexual minorities [28]. As the original work suggested, the intersubjectivity in gender & identity is critical to the mental health of the LGBTQIA+ individuals, while the dictatorial suppression in gender-social-structural hierarchies [29] for geographical & realpolitik ideological controls have been the key cause of country-level stigma in PRC in cases such as [50], and are conductible to the global democracies through monopolizing the ICANN.

2.4 Proliferation Detection and Semantic Analysis

The initial symbolization of the militarily imposed psychological constructs in the regime education system of culture through vocal controls were visually coded in the artwork along with the proliferation from military production [51]. The proliferation and biochemical contamination can be seen in the figures in [12,15,13] from the artwork with gamma levels captured with Cannon 5D MarkII. The regime indoctrination of "listen to the party" and "obey the party" in pre-adulthood educations with linguistic syntax and punish-award gas-lighting violated *rule #27* [11] in prohibiting the use of child soldiers in my early education, and still a nationwide practice with the new "Xi Jinping's Thought". Such indoctrination's psychological impact with relation to the geostationary satellite propaganda incentive designs in the ontological network [9,2] is the key mental & psychological torture method imposed on the population systematically and quantitatively, since the Maoist autocratic dictatorship. It was with this regard, sexism was adopted [15,28] in counteracting the cisgender heterosexual syntax of linguistic manipulation. Further intrusion on militarizing sexuality was analyzed [22] that underlies the psychological torture evidence [17]. In the financial coercion evidences, the explicit threats were made with non-back-traceable numbers [2]. In the psychological and Mental torture files, the use of probable breached privacy data from American society and or military [12] are evidenced. More evidence from those events have not been further reorganized or published.

[20] defined "the video system feeding off telecommunications satellites ... the dominant vehicle for disseminating symbolic environments". For the dictatorial regime, the carriers in the medium are verbal and lingual commands that were pre-designed in the mandatory education system. Whereas I approached those materials from an anthropological psychoanalytic perspective, information coding in nuclear sciences with technical & artistic constructs replaced the linguistic symbolization in carrying the scientific evidence and psychopathological mentality [29,14]. The initial information coding [51,15] with quantum physics principles hence served as a communication method in the pretext of regime suppression on the fundamental freedoms, in non-proliferation, arms control, and disarmament. However, due to the topologically vectored totalitarian telecommunication constructs, the mentalities of war were not well-coded in the initial work, except for a symbolic presentation of the nationalistic elements and cultural-emotional

expressions of those mental products observed in the militantly institutionalized textbooks. Since later with the reporting of American Embassy in Beijing's P.M 2.5 and conclusion of Paris Agreement, the communication through artwork was thought to have served the purposes either relevant or not in the events, and I no longer sought for further developments. As seen in the proposals to the curator [51], the mercantilism approach to globalization was identified to be the base of the problem, with a sociology of knowledge thinking and with the astronomical and cosmological sciences, regarding the ideological constructs in the textbooks I saw, and quantitative restrictions & centralized banking monetary manipulations.

2.5 Social Surveys and Case Study

The initial social surveys were conducted with the professor Zhao Song, whose mother Ping Wang were the first female director in mainland China and was later victimized in the "Cultural Revolution". Roxie, who used to study in London School of Economics and Political Science and now works in the Ministry of Commerce of PRC, used to tell me about the internal money laundering of the high officials with postal minivans. Daughter of an official in Qingdao whose work title is an institutionalized secret and not known to her, Roxie lives in close social contacts with the "second generation reds", including Bo Guagua, Bo Xilai's later son who was studying in Cambridge at that time. Even though Xi's assembling of secret police force of the CPC Disciplinary Committee swore to be purposed to punish the alleged corruptions, the use of such excuses in implementing his loyal personnel in the Chinese institutions [2,42] only further proved, *ex post facto*, that these alleged corruptions have been a consistent war crime approach to the global financial realm [23]. Fanfan, an undergraduate peer who later works in the production and promotion sub-sectors in the cinematic industry in PRC, informed me on the military monetary involvements in the cinematic industry, including the background of Polybona Film Group's military import and export channels in Hong Kong (SAR). Another undergraduate peer Wenwen's father used to be a vice president of the group, came to me and had me walk her around the CUC when Xi Jinping first came to power. Her father used to be close to Jiang Zemin's family, and was asked to Xi Jinping's office "for a cup of tea", as how the Chinese political culture calls on the secret non-violent high-pressure psychological interrogations and negotiations for political interests. The double-entry booking system of the Chinese banking was recognized to be the source of the criminological conducts during my leading the undergraduate co-production, reminded by the producer department's management methods and explanations of the banking credit-debit systems with relation to supplies and the formerly recognized supplies hijacking military doctrines in the modern Chinese history textbooks. Foreign Direct Investment could have made a difference with a competitive economy in the third sector with humanitarian approaches in investment, [52] observed, by the private sector's equities in preserving medical resources with the militarization proliferation, however, the works of the China Banking and Insurance Regulatory Commission, further derogated the financial sectors and militarized the monetary and currency realm in the evidence chain. The psycho-sociological projection of technology to autocratic power started from Mao Zedong's seeking nuclear weaponry se-

crets from USSR and its spies in the USA [45], and continued to the Deng Xiaoping dictatorship with high prices and deterioration to the human rights of the regime. These are contributed by the militant marginalization of civil economy.

In the monetary and financial realm, further deterioration came from the further monopolization of digital currency by centralized banking with relation to the hijacking of supplies. The Western leaders' denial on the offshore realm's military import and export to the import and export regime in "extraterritorial communism", with the implications according to [33], has changed the old "Cold War paradigm" [53] to a global informatics distribution of securities paradigm in geopolitics [54]. It means that the militant monetary transactions are further disguised in the systemic backend, and the totalitarian politics will further derogate the freedom of movement for the liquidity issues from the currency hijacking [23]. Between the military purposed QUASS photon contamination of the thermonuclear environment of outer space [18] and the natural decay designs in Eutelsat, per the paradigm epistemology of [55], the lack of *de facto* econometrics in *de jure* scientific engineering is the result of the dictatorial model of resource management, apart from further hazards to the right to health with electronic warfare, analyzed and evidenced in [12]. Preliminary analysis for preemptive measures on public mental & psychological health has been conceived [29]. In my 2019 research trip in the USA, I noticed that the PRC Consulate General in New York was guarded the New York Police Department, unlike the PLA in the PRC territory. The systemically stigmatized and wrongfully persecuted Falungong members, according to the social surveys in the television industries in PRC who never directly offered evidence but corroborated with the technicalities of television production, protested regularly in front of the building. Wang Lijun's entering into the American Embassy in Chengdu implied that Bo Xilai lost the military power on the Chengdu Military Zone before the event leading to his imprisonment. The metadata gathering for ontological control and militarization is traced back to the author's undergraduate studies in CUC around 2010, and with the reasonable suspicions by the verdict on Bo Xilai's crimes indicted from his wife's alleged murder, the probable cause for the case is placed on Xi Jinping's political prosecution, by the construct of the surveillance apparatus used as instruments on his opponent Bo Xilai as revenge on his childhood bully. I based my graduate research proposal upon this insight, and led to the education institution's suppression before the mainland China constitution change, and victimization thereafter with my continued research independently [2].

Further social survey was conducted along with the case study in a local ABC branch in Chongqing, PRC in Oct. 2022. After the banking clerk received the phone call asking about international transfer, her tone became alerted and I had to be gentle with her in every exchange of conversation, even though it is only \$111.10. There had to be evidences present in order to make the transfer, albeit the \$111.10 was on my account cash. The evidences needed to cover where will the money go to and how will the money be used, and a copy of all relevant documents needed to be given to the bank clerk. I used an excuse of buying books on Amazon.com, with a VISA status change document for F category in America for my mainland China passport, and the clerk partially assured me, or in a way to herself, that buying books is not a

problem. Moreover, all the documents on the money usage need to be associated directly to a copy of the mainland China resident (ID) card. An application needed to be filled in without any signs of revision, and the Simplified Chinese wording subtly differentiated from the English in the interbanking implications with the original category implications. After several hours of evidence preparation, filling and refilling of the application, the clerk worked on the transfer yet cannot be processed in the bank's system. She said that I could have done that on my phone without even filling out all the forms, and I told her that the system showed error on the US banking's SWIFT code. She suspected it could have been because of my opening bank was in Beijing, and I checked with her if my account is associated with Beijing city (local) branch or Beijing headquarter branch, and it is Beijing city (local) branch. It means that all the currency measurements inside of mainland China have been anchored with territorial areas and currency associated with predatory measurements on accumulation of foreign debt bondages.

The initial clerk with her colleague by the side suggested me to have a K-USB for my card so that it may work for international transfer. And the K-USB needed to be assigned by the local branch manager. The manager was by the aisle of the "smart ATM" that can identify every customer by facial recognition. Even though it looks to be a self-help design, all operations on the "smart ATM" need to be "authorized" by the manager or relevant persons with the "administrative power". The manager murmured to me that, if anything "went wrong" she'll be punished and lose job. She also murmured similarly with a warm tone and not the alerted tone to a regular customer in police uniform when he asked about the medical insurance card in the form of bank card. She explained that the channels in the bank are separate according to the card-holder ages, implying that the deliberate calculation of the persons' ages (labor value) to the monetary & currency values in global economy has been leveraged. Another customer showed up wanting to delink a fund to her bank card issued by her university without her prior awareness. I also witnessed the same scenario and same issue with bank card issued by university in Beijing. Apart from the presence of military branches in all the universities in Beijing, including UFWG in all universities in mainland China, SASAC branches are in all mainland China university finance administration departments. The manager had to go to the restroom, and a male colleague with the "administrative power" for finger prints replaced her. He murmured that the "smart ATM" can do many calculations and labelling, implying adapting to the needs of those really behind the powers and the regional totalitarian requirements imposed on the bank clerks, which the manager said earlier on her responsibilities to the local branch clerks with possible associated punishments if anything went against the will of the hierarchy, or in other words the will of the dictator conducted through the hierarchy, with the capacities of monetary calculations precise to each person and individual.

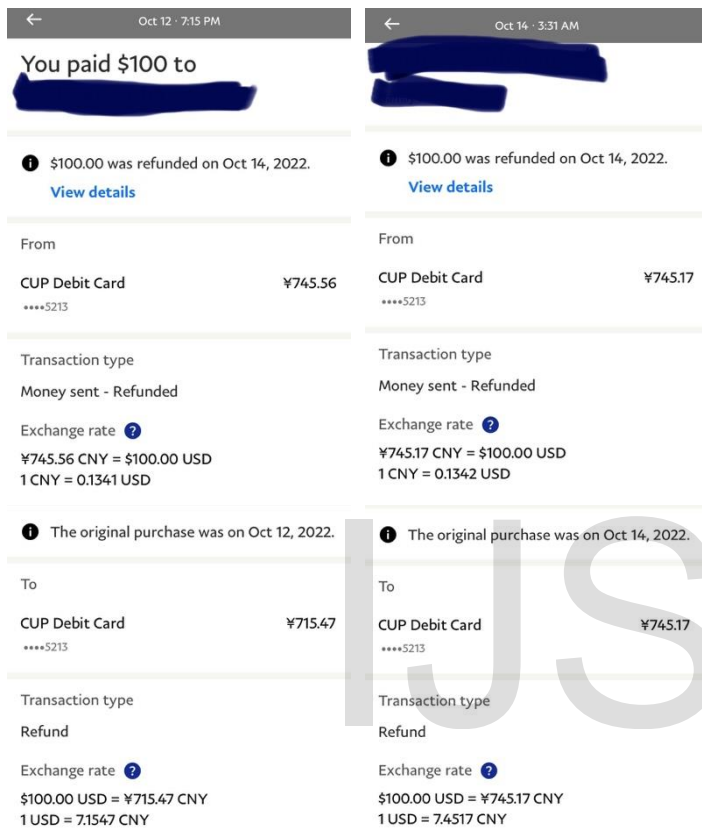


Fig. 6 The comparison groups of relatively fixed outgoing float with drops in refund time differentiation.

At the end, I got the K-USB for the card, but the issue with SWIFT still remained. The initial clerk got anxious and asked me if I had any reservations that did not tell her. By that time with the corroboration from the bank backend, I already confirmed the conduct of SASAC with the banking system and central bank. With what she could have observed daily, I only told her it was because of military spendings before I left. Further corroborations

were conducted through PayPal transfer to America for \$100.00 paid with my Bank of China card. As seen between the contrast of *figure 6*, The initial payment transaction cost was on the time lap. Even though USD is an anchor currency, at the three transactions made on Oct. 14, 2022 had a large portion of differentiation in exchange rate. This differentiated cost evidences the double-entry bookkeeping and SASAC's central bank operations in currency manipulation and marginalization on the civil and market economy.

3 RESULTS

Albeit the phenomenology and effects revealed in the evidence-based approach is complicated, the structural source of transgression remains consistent with the CPC's conducts. Sociology of knowledge is a normative approach to scientific knowledge and bias correction, however, the use of societal control to a knowledge of sociological parameterization is the technical criminology with the dictatorial AI construct [2]. Its deviation from the engineering science [55] was traced back to the forceful construction of the Three Gorges Dam [31] before and around the 1989 Tiananmen Massacre, and continued to the contribution to modern & contemporary individually targetable mass surveillance and human trafficking. The military and militant operations leading to the deterioration on human autonomy and restrictions on fundamental freedom is the main constituent of the criminal intentions. As it was evidenced in [24], the banking industry and telecommunication

surveillance with human trafficking is consistent with the organizational criminology [3], which [56] defined as "social engineering attack ... as a social engineering tool or a threat that causes a risk to cyber security". The evidences on the geopolitical currency manipulation intentions were submitted to the International Court of Justice while identifying the patterns of the harassment.

According to [57], mainland China "was very active in the process of drafting the Rome Statute" and "chose to vote against the adoption of the Rome Statute". Identifying the will of the courts of PRC and differentiating it with those of the autocratic party and governmental apparatus is the main task of implementing the Roman Statute to the territory. Several years ago, the Chinese People's Armed Police Force was separated from the People's Liberation Army ranks, which had a sign of judicial concerns in enforcement. However, the party agendas of pancomputationalism surveillance and the raising of "CPC has to rule everything / everyone", violating the previous Deng reform of "separating the party from the state" before the constitution change after Xi took power imply Xi Jinping's *coup d'état* with the phenomenon of overthrowing "the leader and the leader's primary support coalition" in the latter deviation in [1]'s definition, and "reshuffling coups that replace an incumbent leader while preserving the power of the incumbent ruling coalition" in the main purpose of CPC organizational criminology. It means that the "support for the Court" by the CPC in [57], "[i]f the operation of the court could bring to justice all those individuals who have perpetrated most serious international crimes, this would not only help build confidence in international justice, but will also ultimately contribute to the maintenance of international peace and security. This is the outcome we fervently hope for", is only a strategic rhetoric instead of a statement, [i]f not a contempt of the spirit of the Rome Statute.

In the separation and check and balance doctrines, the ancient fears of extraterritoriality in the globalization context have been a main concern for the academic community, including the retired professor Zhao Song, who worked and lived her whole life in the Chinese military propaganda system of August First Film Studio, when I expressed my concerns on the signs of deterioration from the "separation of party and state". This can be a result from the more than 70 years of nationalism propaganda since the civil war between the CPC and KMT. The deviations from the universality of human rights declarations originates from the civilization consciousness over the liberal and neoliberal institutionalism consciousness. As was evidenced by the marriage law doctrines in mainland China [4], the fascism mentalities have been the core and source of the stigmatization not only for the LGBTQIA+ population, but also the heterosexual families by the implemented totalitarian coercion mechanism. It was also by the very totalitarian coercion mechanism originated from the "lian zuo" culture from the imperial rule roots, Bo Xilai was "convicted" of his crimes by his wife's connections to the murdered British businessman whom some of the military personnel of PRC rumored to be British spy, possibly from the top-down lies. It is by the very case of deep political interests, the Chinese court's will in the spirit of Rome Statute and basic notions

of justice has been put into question, analogous to the "Gang of Four" and "cultural revolution". In the modern and contemporary constructs, the intrusion of privacy by the closed internet system is the source of the "frame the blame" doctrines of "law" in the technologically exacerbation of "cultural revolution" combined with "cloud trials" in extracting monetary markets for currency controls, with international arbitration as choice of law for evading justice.

The evidence chain and analysis imply that the human rights derogation in the mainland China territory is a result from the gross transgressions on the Geneva Conventions. It is consistent with the regime prosecutions of the human rights lawyers after Deng Xiaoping's retirement and before Xi Jinping took power. For LGBTQIA+ human rights, Yinhe Li's long years of decriminalization and destigmatization, and later years of failed legalization efforts, have hence diagnosed to be the lack of "reproduceability" of the forced labor groups in the eyes of the autocratic power, compared to the ease of financial coercion upon the cisgender heterosexual groups. Therefore, the sex trafficking I experienced and common in the regime cyber environment has been considered for an attempt based on military psychology analysis for devising psychosocial coercion mechanisms on the LGBTQIA+ population with the international and civil pressures of legalizing LGBTQIA+ marriage. The state-backed chip productions [58] in Chongqing regardless of the public health hazards, with the plausible cause, are related to its 5G infrastructure with "cyber sovereignty" claims and SASAC monopolization of civil & market economy. The Denial-of-Service attacks in preserving the technologically operated totalitarian autocracy are also evidenced to be not only transgression to the right to health of the civil society, but also a nontraditional nuclear threat to the regional population [12]. With the analysis on monetary interests, the state power's corruption with the military realpolitik power of Xi Jinping is the motivation for the instigated crime. The obstructions on my academic research during my graduate studies, and later human trafficking crimes inflicted on me [2] are hence recognized to be an effort of destroying witness. This is consistent with the attempt to dishonor me with poison pen letter to my birth mother [24] who has been taking care of me after the human trafficking harms, with psychological threats that undermine her mental & psychological health in her retirement life.

The mainland China attempts of marginalizing Taiwan through the chip production industry and mass surveillance cyber network expansion encountered rightful interventions from the USA [59], however, with the marginalization of Taiwan in the power political occasions such as the United Nations Security Council (UNSC), the derogation of human rights in the region can worsen if Taiwan is not a signatory state to the Rome Statute [12]. The military conduct behind the cyber & communication system network marginal intrusion can be defined similarly in the breach of Geneva Conventions with the "One Country Two System" doctrines without acknowledging "one nation" throughout the years, with derogation to the democracy in Hong Kong (SAR). The linguistic duality between English and Simplified Chinese is not only a dictatorial AI construct for propaganda that harms the mental

& psychological health and cognitive health of the population exposed, its coercion incentive indoctrination marginalizing human autonomy with power seizure by structural realism is the fundamental gas-lighting technique of the propaganda system [29]. The marginal effects on the LGBTQIA+ communities require better mental resilience of the gender & sexual minorities [22] with the heightened effects on the suicidal rates across countries and via the domains. With the targeted coercion incentive implementations analogous to pulsars with my self-psycho-mental-health care, the conceptualization of the cyber criminology was aided by the psychoanalytic approach across the time domain observations on the organizational behaviors with satellite back-end accesses [28,46]. The quantum transference and countertransference application [27] has been my method in preserving my psychological health [60] with the criminological analysis and conceptualization. The results are consistent with the technical analysis on the negative lists associated with the PRC centralized banking and cyber-based back-end operations evidenced in [2,18].

With the mass-scale coercion mechanism instituted, the fascist mass psychology phenomena are recognized to be the unfulfilled freedom from fear even with the state declared to exist. While suppressing voices contrary to the CPC narratives from the territorial population for relative gains in power and realpolitik, or absolute gain in the interest of the CPC hierarchy, is a cultural anthropological result, the institutional behaviors & organizational behaviors gravely trespassing the Geneva Conventions are not from bottom-up causes. Even though cases such as the ABC cognitively know the better, the coerced activities became a routine obsessive-compulsive disorder for financial incentives of psychopathological reinforcement, with its organizational behavioral impact from Xi Jinping [2] behind all the apparatus and hierarchy.

4 CONCLUSIONS

Apart from the anthropological and sociological variants that prevent the population from democratic imaginations under the propaganda generation systems, the constitutionalism of PRC is the source of gross human rights breaches, with the CPC party power superimposed over the natural laws of human rights. With the dual identities of regime autocratic dictatorship and UNSC permanent five memberships, the bureaucratic constructs of personal power and marginalization is the source of military aggression on the civil society and human rights work. It is exactly this mentality that contributes to the human rights transgression on the Uighur ethnic minorities mainly consist of Nomad agricultural production. The mass import of food by the regime dictatorial group implies that the crimes conducted transgressing the civil right to health are willfully and consciously conducted, which are the basis of its crimes of genocide with the Geneva Conventions and Roman Statute definitions. With the bureaucratic structures of decision-making, any person in that position is bound to conduct such crimes, and the person in that position now is Xi Jinping. It is with the analysis, regime change is not the purpose, but the end in itself in the spirit of the UDHR that serve as the legitimacy basis of the UNSC. The rationality of population statistical sampling and representation is constituted in the USA constitutionalism, while the

Chinese constitutionalism is structurally a military rule upon the civil society. Therefore, the path of democratization for mainland China is not without necessities on guidance from the Rome Statute.

The dilemmas between the spirit of law and enforcing the law is persistent with regard to the nuclear power with consistent threats made to the international society. Even if sectors in the state government of PRC have the will for change, the intricacies between ending impunity and another *coup d'état* are quite subtle. The narcissist all-encompassing power of dictatorial & autocratic psychopathology spread in the governmental & organizational bodies is the major contributing factor for the subtleties. The procedural justice between ending impunity and empowerment through democratization is still the "check and balance", only that in the case of PRC it is through the multilateral approaches and a multi-party democracy formation, in the stead of "multi-party consultancy" with a sole party holding the violent means of negotiation in the territory. The PRC nationalism propaganda is incentivized by Japan's multilateral positions in possible cooperative defense with the Republic of China with nuclear weapons across the Taiwan Strait deployed by the PLA. The use of propaganda in gas-lighting the minimal democratic processes is a usual practice of the CPC, hence the involvement of the Nanjing Military Zone's role in the previous attempt to attack Taiwan during the most intense periods of propaganda generation before COVID-19 and during the Trump Administration. Democratization of the mainland China territory will also benefit the arms control and disarmament causes for the USA's necessities in peacekeeping Japan as a result of World War II, and deterrence for peace across the Taiwan Strait by increasing precision strike efficacy.

The same reasoning on the UNSC's appropriate positions in a coalesced defense for near-earth object threat mitigation still holds true, with the premise of energy conservation laws in the productions of the weapons to begin with. However, with the dictatorial AI automation with deep interests in the monopolization with the internet domains with new currency technologies, the nested interests surrounding the dictatorial group and stakeholders for the dictatorial power always incline all possible actions to the traps of *coup d'état*, with the courts of PRC included. Therefore, *Art. 17* of the Rome Statute [21], "a case is admissible before the Court only when the state responsible for prosecution can be shown to be unwilling or unable to investigate and prosecute it", was enacted [2]. However, due to the preconditions of the *coup d'état*, the letter from [61] referenced *Art. 12* and *13* that "the Court may only exercise jurisdiction over international crimes if (i) its jurisdiction has been accepted by the State on the territory of which the crime was committed, (ii) its jurisdiction has been accepted by the State of which the person accused is a national, or (iii) the situation is referred to the Prosecutor by the Security Council acting under Chapter VII of the UN Charter". The marginalization of the International Criminal Court (ICC) from the withdrawal from the Bush Administration with possible correlations to Russia was a milestone on the ICC's capabilities to act. The post-911 delegitimization of the United Nations contributed to the further human rights deterioration to the extremities of transgressing the Geneva Conventions.

Even though [62] is not wrong in "America first", the semantics of the QUESS nuclear threats (Micius) were not recognized in the logic of global mercantilism in the literary approaches of persua-

sion. Furthermore, the propaganda semantics dubbed "America first" to "dominant supreme hegemonic power" in the Simplified Chinese publications, in a nationalist propaganda approach in sustaining the marginal military expansionism approach, notably by [63] in accordance to the ontological construct of the Big Data surveillance. It means that if the ICC is maliciously used by the UNSC under Chapter VII of the UN Charter, further deterioration to global anarchy is possible if not already is so. During the Japanese militarism in World War II that threatened the NASA Deep Space Network [23], the Manhattan project in ending global power politics contributed to the deprivations of Japan's armed forces. Similar logic can be true for democratization in military surrogacy in the stead of competing for military power control between militarism and court functions in enforcement and gaining judicial independence, which was listed in the KMT constitutionalism but derogated by the CPC constitutional dictatorship, which in its structural form is imperialist with its UNSC status. By submitting the military power to the International Court of Justice in democratization transitions, the United Nations peacekeeping force can be maintained, while the mass psychological impact on the public mental & psychological health can be minimized.

With the non-functioning of the legal system of PRC, the Rome Statute is not enforceable of the territory. However, the principle of universality in human rights may still apply [64] for universal jurisdiction *in absentia*. With the informatics technologies, Xi Jinping further developed a CPC APP monitoring all its members' "learning from Xi Jinping", with a "One Center and Four Basic Elements" internal policy before the constitution change. The surrogacy of all population to his personal power and thinking has been evidenced with all the organizational details, especially with cyber-based criminological management. This also correlates the technological developments in the PRC contexts to his personal ambitions and lust, including the increased conflicts with the Republic of China, which was initially the permanent five member of the UNSC but reverted to PRC because of the Stalin dictator's efforts [45].

5 DISCUSSIONS

With the QUESS contamination of the outer space thermonuclear environment by photon beams, the predetermined quantitative impact on earth needs to be thoroughly examined by the nuclear scientists, notably International Atomic Energy Agency and the European Organization for Nuclear Research. More subtle is the astrobiological researches between the earth's nuclear environment and RNA & DNA co-determinants. By the projection of its own militarism developments with modern technological constructs [65], China's accusations on the scientific genetic databases regarding the Ukrainian war and even before COVID-19 have been a subtle power political approach in furthering its human trafficking capabilities. Even with forensic investigations, determining the murder crimes does not need DNA samples unless it was the massacre events or serious arsonist crimes. The co-determinants of outer space thermonuclear environment impact are more plausibly to be drawn from RNA bio-diversities, and compatibility to DNA research. With the militarism of *coup d'état*, the reported suicides of the China Railway Group's vice president, which is mostly associ-

ated with military transportation, and the Chief Financial Officer of Polybona Film Group, which is mostly associated with military finance, are more important leads to investigation other than the DNA samples of the Uighur minority population on individualistic basis. The psycho-pathological co-determinants driving the bureaucratic behaviors are the persecution delusional disorders of the never-justified autocracy and dictatorship resulted from the criminological conducts sustaining its power. However, with the tradition of the CPC politics with secret police, military hospitals, and control of information, such efforts in normative reasoning may not be as sound as it should be.

Since the Chinese People's Armed Police Force was separated from the PLA rankings, the conducts of the police collecting individual DNA samples [65] can only be institutionally the state departments' conducts. This further corroborates that the state departments of PRC, with Courts included, have been the sources of human rights transgressions in the mainland China territory, apart from the PLA's transgression of the Geneva Conventions. Such conducts of an autocratic dictatorial regime of the UNSC permanent five member can use power political rhetoric of anti-terrorism for their military aggression in marginalizing regional human security and increasing its military bases with continued hijacking of the supply side that underlies the Communist constitutionalism. This called for my consistent approach in the evidence-driven research in scientific communication with the global institution and communities, especially after the initial suppression on the COVID-19 information by the regime and later obstruction on the World Health Organization in listing it as a global public health emergency, which could have raised the global society's autonomous awareness and responses coordinatedly to the humanitarian crisis. It is for this regard; the psychopathology of fascism has been the major cause for the dysfunctions of the liberal and neoliberal institutionalism.

Another notice from my astronomical and cosmological research during the publication process was the stigmatization of the ANTARES designs & scientific output [66,67], which was informed by the American Astronomical Society journal's editorial replies on my reference on the dark matter annihilation in the sun in my cosmological observations. Possible hiding from scientific evidence by discrediting legit scientific findings & results as a mild approach to destroying evidence is a reasonable suspicion with the militant QUESS designs & actual deployments. The international and global liabilities mean that the Chinese population will be bound for compensation with the arbitration of international law, and any new government will be liable not only for the expenses from the contamination, but also unlimited liabilities to the natural persons of the regime population [62]. If the people are already victims of the institutionalized organizational crimes, is it just to further burden the people for the debts of the criminals? If the criminology originates from the UNSC, would international solidarity contribute anything further to the predetermined future with possible changes that can be made by human efforts? The punishments of criminal liabilities is hence seen as the first and foremost atonement to the prevention of further human rights deterioration with such structural realist crimes, and democratization discussions are not negotiation tables. The latter is a deeply rooted dysfunction of the Chinese justice system ever since the "Gang of Four", if not contributed by the military doctrines during the civil war periods. Em-

powerment in democratization process with the psychopathological spread of the regime is hence a deeper mass psychology question. However, without open government and freedom of information, the good faiths of the Rome Statute cannot be fulfilled, and further injustice in the global security regime can still occur.

It is not only of the human conscience, but with the universality of the correlates and causality of crimes subtle yet detrimental to the sustainability of the natural environment, and the survival of the population with weakest social safety networks in the law of jungle game created by Xi Jinping, who took the autocratic and dictatorial actions to the extremes even before Putin, the universality of the criminalistic intent and impacts should be justified for the war crime by universal jurisdiction. Even though the evidence from the cinematic production is institutionally correlated instead of personally correlated, the institutional and organizational criminology from its structural conduct on deviation from the founding principles of the United Nations should disqualify the militant regime from the UNSC, instead of letting it terrorizing the civil society and global community with its covert schemes of enslavement from structural realist transgressions and further harms. In the cyber chaos of development in events, social media based outside of mainland China started to adopt censorship policies curbing to the narratives of the power political regime, possibly by the financial incentives combined with threats. The acknowledgment of negative emotions needs to be respected, without which no rationalization on the origins of such emotions can be located.
