## **Interim Corpus Separatum for the Palestine Question**

The Security Council,

*Emphasizing* the need for the United Nations and the international community to facilitate preemptively a controlled situation wherein measures stated in this draft resolution be adopted if Israel does not implement Resolution 2334 (2016),

*Noting* with deep concern the ongoing conflict and humanitarian situation and reiterating condemnation of all terrorism as well as all violations of the human rights of Palestinians,

Stressing a deep concern about the security of civilians and calling upon both parties to address a viable solution,

*Reaffirming* relevant resolutions that has been made, including Resolution 2546 (1969), Resolution 2628 (1970) and Resolution 31/20 (1976) and Resolution 3236 (1974),

*Reaffirming* Resolution 181 (II), passed on November 29, 1947, provided for the full territorial internationalisation of Jerusalem: "The City of Jerusalem shall be established as a *corpus separatum* under a special international regime and shall be administered by the United Nations,

Emphasizing the inadmissibility of the acquisition of territory by war and the need to work for a just and lasting peace in which all people in the area can live in security while believing that the principles underlying its previous resolutions concerning this matter, and that in particular its resolution of 29 November 1947, represent a just and equitable settlement of these issues as such also earlier proposed by President Harry S. Truman on 25 March 1948,

- 1. To state, therefore, its intention that "Palestinian territories" and "occupied Palestinian territories" (OPT or oPt) should be placed under a permanent international regime which should envisage appropriate guarantees for the protection of the Palestinian people's human rights and achieving a just settlement for original refugees who meet UNRWA's Palestine Refugee criteria both within and outside of the territories and to affirm;
- 2. Establishment of corpus separatum under a special international regime and administered by the reestablishment of the International Trusteeship System, herewith currently active under the UN Charter as the Trusteeship Council the arrangement shall last for a seven-year interim period during which a permanent agreement would be negotiated for a two-State solution;

- 3. *Termination* of all claims or states of belligerency and respect for and acknowledgment of the Trusteeship System, territorial integrity and political independence of all people in the area and their right to live in peace within secure and recognized boundaries on the basis of the 1967 lines free from threats or acts of terrorism from both Israeli and Palestinian sovereignty proclaimers;
- 4. *Urges* for guaranteeing the success of the corpus separatum drafting of a uncodified constitution whereunto the Trusteeship Council and Administering Authority must pass codified basic laws governing all affairs of the territories under a special international regime by such overruling the unsettled status of Palestinian law as administered by the Palestinian National Authority within the territory pursuant to the Oslo Accords;
- 5. Requests for achieving a lasting possibility of peace and acceptance among the people in the territories under special international regime the Trusteeship Council must henceforth mandate and focus UN's nation-building efforts to transform these unstable territories with specialized urban planning and technology-intensive driven development to combat growing divisions that diminish sustainability efforts;
- 6. Request for guaranteeing the territorial inviolability and interim independence of the corpus separatum the UN Security Council must henceforth declare that all illegal practices of the occupation including Israel's blockade on the Gaza Strip and all settlement activity as the existence of a threat to the peace of corpus separatum and breach of the peace and act of aggression in accordance with Article 39 of the UN Charter and authorize the deployment of a peacekeeping operation and proceed immediately with its implementation whereas The Trusteeship Council shall not allow any actions taken by any interested Government or Governments to divert it from adopting and implementing carrying out its mandate;
- 7. Requests the Secretary-General to designate a Special Representative to proceed to the Middle East to establish and maintain contacts with the parties concerned in order to assist efforts to achieve a peaceful and accepted corpus separatum in accordance with the provisions and principles in this resolution;
- 8. Requests the Secretary-General to report to the Security Council on the progress of the efforts of the Special Representative as soon as possible and calls upon the parties concerned to make formal undertakings that they will approach these matters with good will and be guided by the terms of the present resolutions;
- 9. *Confirms its determination* to support the parties throughout the negotiations and in the implementation of the corpus separatum.
